- **Oral testimony:** fill out a paper witness card at the registration table outside the hearing room, E1.036 and submit to SFC staff.
- Oral and written testimony: fill out a paper witness card at the registration table outside the hearing room, E1.036 and submit your witness card and written testimony to SFC staff.
- **Position only:** register using the Senate kiosk located in the extension hallways or by going to http://swrs on public-capitol. Kiosk registration will open 30 minutes before the hearing begins.
- Written testimony only: register your position using the Senate kiosk and then bring 20 copies, with your name on each copy, to the registration table outside the hearing room, E1.036 and submit to SFC staff.
