Relating to state contracts with and investments in social media companies that censor political speech.

SB 1178 Birdwell

Relating to the rights and duties of parents and the protection of parental rights in suits affecting the parent-child relationship.

SB 1339 Zaffirini

Relating to the authority to request attorney general advice on questions relating to actions in which the state is interested.

SB 1496 Huffman

Relating to removal of certain intimate visual material by a search engine operator of an Internet website; imposing a civil penalty.

SB 1678 Campbell

Relating to the prohibited release by a public agency of information regarding the members, supporters, or volunteers of or donors to certain nonprofit organizations; creating a criminal offense.

SB 1936 Hughes

Relating to the beginning and ending possession times in certain standard possession orders in a suit affecting the parent-child relationship.
