A BILL TO BE ENTITLED

1 AN ACT
2 relating to the establishment of the Texas Police Service Animals
3 Memorial Monument in the Capitol Complex.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Subtitle A, Title 11, Government Code, is
6 amended by adding Chapter 3107 to read as follows:

7 CHAPTER 3107. TEXAS POLICE SERVICE ANIMALS MEMORIAL MONUMENT

8 Sec. 3107.001. DEFINITIONS. In this chapter:

9 (1) "Board" means the State Preservation Board.

10 (2) "Capitol Complex" has the meaning assigned by
11 Section 443.0071.

12 (3) "Monument" means the Texas Police Service Animals
13 Memorial Monument.

14 (4) "Police service animal" has the meaning assigned
15 by Section 38.151, Penal Code.

16 Sec. 3107.002. TEXAS POLICE SERVICE ANIMALS MEMORIAL
17 MONUMENT. Subject to Section 443.0152, the board shall establish a
18 Texas Police Service Animals Memorial Monument using board approval
19 procedures on the grounds of the Capitol Complex adjacent to the
20 Texas Peace Officers' Memorial Monument to recognize and honor
21 police service animals that were killed in the line of duty.

22 Sec. 3107.003. MAINTENANCE OF MONUMENT. (a) The board is
23 responsible for the maintenance of the monument. The board may
24 receive money from private entities for the continued maintenance

1 and update of the monument. The board shall:

2 (1) establish a schedule for the maintenance of the
3 monument; and

4 (2) select persons to maintain the monument.

5 (b) An entity that collects funds for the maintenance and
6 improvement of the monument shall send that money to the board to be
7 deposited in the Capitol fund account.

8 Sec. 3107.004. ACCOUNT. (a) Money contributed to the state
9 for a purpose related to the monument shall be deposited by the
10 board in the Capitol fund to the credit of a separate
11 interest-bearing account established for the monument.

12 (b) Notwithstanding any other law, income from investments
13 of money in the account shall be deposited to the credit of the
14 account.

15 (c) Money in the account may be used only for the purposes
16 prescribed by Section 3107.003.

17 SECTION 2. This Act takes effect September 1, 2021.

9 deposited in the Capitol fund account.

12 in the Capitol fund to the credit of a separate interest-bearing
13 account established for the monument.
