

- Sec. 577A.101. MINIMUM STANDARDS. The executive

- 2 certification of psychiatric residential youth treatment
- 3 facilities under this chapter. The minimum standards must require
- 4 a facility to:
- 5 (1) obtain accreditation by The Joint Commission, the
- 6 Commission on Accreditation of Rehabilitation Facilities, the
- 7 Council on Accreditation, or another accrediting organization
- 8 approved by the commission; and
- 9 (2) provide and prescribe guidelines for the provision
- 10 of the following activities, treatments, and services:
- 11 (A) development and implementation of individual
- 12 plans of care, including the provision of services provided by a
- 13 licensed psychiatrist or physician to develop individual plans of
- 14 care;
- 15 <u>(B)</u> individual therapy;
- 16 (C) family engagement activities;
- 17 (D) consultation services with qualified
- 18 professionals, including case managers, primary care
- 19 professionals, community-based mental health providers, school
- 20 staff, and other support planners;
- 21 <u>(E) 24-hour nursing services; and</u>
- 22 (F) direct care and supervision services,
- 23 supportive services for daily living and safety, and positive
- 24 behavior management services.
- Sec. 577A.102. ADMISSION CRITERIA. A facility certified
- 26 under this chapter may not admit or provide treatments or services
- 27 to an individual unless the individual:

- 1 (1) is 21 years of age or younger;
- 2 (2) has been diagnosed with a severe emotional
- 3 disturbance by a licensed mental health professional;
- 4 (3) requires residential psychiatric treatment under
- 5 the direction of a licensed physician to improve the individual's
- 6 condition; and
- 7 (4) was referred for treatments or services in a
- 8 psychiatric residential youth treatment facility by a licensed
- 9 mental health professional.
- 10 <u>SUBCHAPTER D. ENFORCEMENT</u>

It is assumed revenue generated from application and renewal fees in fiscal years 2024 through 2026 would be sufficient to cover costs related to implementing the provisions of the bill.

Upgrades to CLASS, the Public Provider Portal, and CLASSMate are assumed to require a total of 12.8 FTEs in fiscal year 2022, 10.2 FTEs in fiscal year 2023, and 8.0 FTEs in subsequent fiscal years at an estimated cost of \$2.3 million in fiscal year 2022, \$1.6 million in fiscal year 2023, \$1.0 million in subsequent years. FTE-related IT costs are estimated to be \$26,001 in fiscal year 2022, \$7,719 in fiscal year 2023, and \$5,185 in subsequent years.

Local Government Impact

No fiscal implication to units of local government is anticipated.
