A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to complaints filed with the State Board of Veterinary
- 3 Medical Examiners.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 801.207, Occupations Code, is amended by
- 6 amending Subsections (b) and (c) and adding Subsections (b-1),
- 7 (b-2), and (b-3) to read as follows:
- 8 (b) Except as provided by Subsections (b-1) and (b-2), each
- 9 [Each] complaint, investigation file and record, and other
- 10 investigation report and all other investigative information in the
- 11 possession of or received or gathered by the board or the board's
- 12 employees or agents relating to a license holder, an application
- 13 for license, or a criminal investigation or proceeding is
- 14 privileged and confidential and is not subject to discovery,
- 15 subpoena, or other means of legal compulsion for release to anyone
- 16 other than the board or the board's employees or agents involved in
- 17 discipline of a license holder.
- 18 (b-1) The board shall provide a copy of each complaint to
- 19 the license holder who is the subject of the complaint not later
- 20 than the 14th day before the date any response is due, unless
- 21 providing a copy of the complaint would jeopardize an
- 22 investigation. The board may not require the license holder to
- 23 request a copy of the complaint.
- 24 (b-2) The board shall provide to the complainant a copy of

- 1 any response to the complaint the license holder provides not later
- 2 than the 14th day after the date the board receives the response,
- 3 unless providing the copy would jeopardize an investigation or the
- 4 act alleged in the complaint is not under the board's jurisdiction.
- 5 If the board provides a copy of a response to a complainant, the
- 6 board shall include with the copy notice of the complainant's
- 7 opportunity to rebut the license holder's response.
- 8 (b-3) The board is not required to provide a copy of the
- 9 complaint under Subsection (b-1) or a license holder's response
- 10 under Subsection (b-2) for a complaint initiated by the board.
- 11 (c) Except as provided by Subsection (b-1), the [The] board
- 12 shall protect the identity of a complainant to the extent possible.
- SECTION 2. Section 801.207, Occupations Code, as amended by
- 14 this Act, applies only to a complaint filed with the State Board of
- 15 Veterinary Medical Examiners on or after the effective date of this
- 16 Act. A complaint filed with the board before the effective date of
- 17 this Act is governed by the law in effect on the date the complaint
- 18 was filed, and the former law is continued in effect for that
- 19 purpose.
- 20 SECTION 3. This Act takes effect September 1, 2021.
