| 10 | SUBCHAPTER A. GENERAL PROVISIONS                                  |
| 11 | Sec. 7950A.0101. DEFINITIONS. In this chapter:                    |
| 12 | (1) "Board" means the district's board of directors.              |
| 13 | (2) "Commission" means the Texas Commission on                    |
| 14 | Environmental Quality.  |
| 15 | (3) "Director" means a board member.                              |
| 16 | (4) "District" means the Travis County Municipal                  |
| 17 | Utility District No. 27.  |
| 18 | Sec. 7950A.0102. NATURE OF DISTRICT. The district is a            |
| 19 | municipal utility district created under Section 59, Article XVI, |
| 20 | Texas Constitution.   |
| 21 | Sec. 7950A.0103. CONFIRMATION AND DIRECTOR ELECTION               |
| 22 | REQUIRED. The temporary directors shall hold an election to       |
| 23 | confirm the creation of the district and to elect five permanent  |
| 24 | directors as provided by Section 49.102, Water Code.              |

| 15 | or maintenance of macadamized, graveled, or paved roads, or          |

(a) On or after the 8 9 effective date of the Act enacting this chapter, the owner or owners of a majority of the assessed value of the real property in the 10 district may submit a petition to the commission requesting that 11 the commission appoint as temporary directors the five persons 12 13 named in the petition. The commission shall appoint as temporary directors the five persons named in the petition. 14 15 (b) Temporary directors serve until the earlier of: 16 (1) the date permanent directors are elected under Section 7950A.0103; or 17 18 (2) the fourth anniversary of the effective date of 19 the Act enacting this chapter. 20 (c) If permanent directors have not been elected under Section 7950A.0103 and the terms of the temporary directors have 21 expired, successor temporary directors shall be appointed or 22 reappointed as provided by Subsection (d) to serve terms that 23 24 expire on the earlier of: 25 (1) the date permanent directors are elected under Section 7950A.0103; or 26 27 (2) the fourth anniversary of the date of the

| 16 | the contract have been approved by a majority of the district voters |

Sec. 7950A.0502. TAXES FOR BONDS. At the time the district issues bonds payable wholly or partly from ad valorem taxes, the board shall provide for the annual imposition of a continuing direct ad valorem tax, without limit as to rate or amount, while all or part of the bonds are outstanding as required and in the manner provided by Sections 54.601 and 54.602, Water Code.

Sec. 7950A.0503. BONDS FOR ROAD PROJECTS. At the time of issuance, the total principal amount of bonds or other obligations jissued or incurred to finance road projects and payable from ad valorem taxes may not exceed one-fourth of the assessed value of the real property in the district.

SECTION 3. (a) The legal notice of the intention to introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies,

officials, or entities to which they are required to be furnished
 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
 Government Code.

4 (b) The governor, one of the required recipients, has
5 submitted the notice and Act to the Texas Commission on
6 Environmental Quality.

7 (c) The Texas Commission on Environmental Quality has filed its recommendations relating to this Act with the governor, the 8 9 lieutenant governor, and the speaker of the house of representatives within the required time. 10

(d) All requirements of the constitution and laws of this state and the rules and procedures of the legislature with respect to the notice, introduction, and passage of this Act are fulfilled and accomplished.

15 SECTION 4. (a) If this Act does not receive a two-thirds 16 vote of all the members elected to each house, Subchapter C, Chapter 17 7950A, Special District Local Laws Code, as added by Section 1 of 18 this Act, is amended by adding Section 7950A.0306 to read as 19 follows:

20 <u>Sec. 7950A.0306. NO EMINENT DOMAIN POWER. The district may</u> 21 not exercise the power of eminent domain.

(b) This section is not intended to be an expression of a
legislative interpretation of the requirements of Section 17(c),
Article I, Texas Constitution.

25 SECTION 5. This Act takes effect immediately if it receives 26 a vote of two-thirds of all the members elected to each house, as 27 provided by Section 39, Article III, Texas Constitution. If this

Act does not receive the vote necessary for immediate effect, this
 Act takes effect September 1, 2023.
