A BILL TO BE ENTITLED

AN ACT

2 relating to the calculation of certain ad valorem tax rates of a 3 taxing unit and the manner in which a proposed ad valorem tax rate 4 that exceeds the voter-approval tax rate is approved; making 5 conforming changes.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

7 SECTION 1. Section 48.202(f), Education Code, is amended to 8 read as follows:

9 (f) For a school year in which the dollar amount guaranteed level of state and local funds per weighted student per cent of tax 10 11 effort ("GL") under Subsection (a-1)(2) exceeds the dollar amount guaranteed level of state and local funds per weighted student per 12 cent of tax effort ("GL") under Subsection (a-1)(2) for the 13 preceding school year, a school district shall reduce the 14 district's tax rate under Section 45.0032(b)(2) for the tax year 15 16 that corresponds to that school year to a rate that results in the amount of state and local funds per weighted student per cent of tax 17 effort available to the district at the dollar amount guaranteed 18 level for the preceding school year. A school district is not 19 20 entitled to the amount equal to the increase of revenue described by 21 this subsection for the school year for which the district must reduce the district's tax rate. For [Unless Section 26.042(e), Tax 22 23 Code, applies to the district, for] a tax year in which a district must reduce the district's tax rate under this subsection, the 24

1 district may not increase the district's maintenance and operations tax rate to a rate that exceeds the maximum maintenance and 2 3 operations tax rate permitted under Section 45.003(d) or (f), as applicable, minus the reduction of tax effort required under this 4 5 subsection. This subsection does not apply if the amount of state funds appropriated for a school year specifically excludes the 6 amount necessary to provide the dollar amount guaranteed level of 7 state and local funds per weighted student per cent of tax effort 8 under Subsection (a-1)(2). 9

SECTION 2. Section 3828.157, Special District Local Laws
Code, is amended to read as follows:

Sec. 3828.157. INAPPLICABILITY OF CERTAIN TAX CODE ROVISIONS. Sections 26.04, [26.042,] 26.05, and 26.07, [and <u>26.075,</u>] Tax Code, do not apply to a tax imposed under Section 3828.153 or 3828.156.

SECTION 3. Section 8876.152(a), Special District Local Laws
Code, is amended to read as follows:

18 (a) Sections 26.04, [26.042,] 26.05, 26.06, 26.061, and
19 26.07, [and 26.075,] Tax Code, do not apply to a tax imposed by the
20 district.

21 SECTION 4. Section 26.012(3), Tax Code, is amended to read 22 as follows:

(3) "Current debt <u>service</u>" means <u>the minimum dollar</u>
 <u>amount required to be expended for</u> debt service for the current
 year.

26 SECTION 5. Section 26.04(c), Tax Code, is amended to read as 27 follows:

Sections 26.041(a), (b), and (c), Tax Code, are 25 amended to read as follows: (a) In the first year in which an additional sales and use 26 tax is required to be collected, the no-new-revenue tax rate and 27

where "sales tax gain rate" means a number expressed in dollars per \$100 of taxable value, calculated by dividing the revenue that will be generated by the additional sales and use tax in the following year as calculated under Subsection (d) by the current total value.

(b) Except as provided by Subsections (a) and (c), in a year in which a taxing unit imposes an additional sales and use tax, the voter-approval tax rate for the taxing unit is calculated according to the following formula, regardless of whether the taxing unit levied a property tax in the preceding year:

7 where "last year's maintenance and operations expense" means the 8 amount spent for maintenance and operations from property tax and 9 additional sales and use tax revenues in the preceding year, and 10 "sales tax revenue rate" means a number expressed in dollars per 11 \$100 of taxable value, calculated by dividing the revenue that will 12 be generated by the additional sales and use tax in the current year 13 as calculated under Subsection (d) by the current total value.

14 (c) In a year in which a taxing unit that has been imposing 15 an additional sales and use tax ceases to impose an additional sales 16 and use tax, the no-new-revenue tax rate and voter-approval tax 17 rate for the taxing unit are calculated according to the following 18 formulas:

6 where "sales tax loss rate" means a number expressed in dollars per 7 \$100 of taxable value, calculated by dividing the amount of sales 8 and use tax revenue generated in the last four quarters for which 9 the information is available by the current total value and "last 10 year's maintenance and operations expense" means the amount spent 11 for maintenance and operations from property tax and additional 12 sales and use tax revenues in the preceding year.

13 SECTION 7. Section 26.07(b), Tax Code, is amended to read as 14 follows:

15 (b) If the governing body of a [special] taxing unit [or a municipality with a population of 30,000 or more] adopts a tax rate 16 17 that exceeds the taxing unit's voter-approval tax rate, [or the governing body of a taxing unit other than a special taxing unit or 18 a municipality with a population of less than 30,000 regardless of 19 whether it is a special taxing unit adopts a tax rate that exceeds 20 the greater of the taxing unit's voter-approval tax rate or de 21 minimis rate,] the registered voters of the taxing unit at an 22 23 election held for that purpose must determine whether to approve 24 the adopted tax rate.

25 SECTION 8. Sections 31.12(a) and (b), Tax Code, are amended 26 to read as follows:

27

(a) If a refund of a tax provided by Section 11.431(b),

1 26.07(g), [26.075(k),] 26.15(f), 31.11, 31.111, or 31.112 is paid 2 on or before the 60th day after the date the liability for the 3 refund arises, no interest is due on the amount refunded. If not 4 paid on or before that 60th day, the amount of the tax to be refunded 5 accrues interest at a rate of one percent for each month or part of a 6 month that the refund is unpaid, beginning with the date on which 7 the liability for the refund arises.

8 (b) For purposes of this section, liability for a refund 9 arises:

10 (1) if the refund is required by Section 11.431(b), on 11 the date the chief appraiser notifies the collector for the taxing 12 unit of the approval of the late homestead exemption;

13 (2) if the refund is required by Section 26.07(g) [or 14 26.075(k)], on the date the results of the election to approve [or 15 reduce] the tax rate[, as applicable,] are certified;

16 (

(3) if the refund is required by Section 26.15(f):

17 (A) for a correction to the tax roll made under 18 Section 26.15(b), on the date the change in the tax roll is 19 certified to the assessor for the taxing unit under Section 25.25; 20 or

(B) for a correction to the tax roll made under Section 26.15(c), on the date the change in the tax roll is ordered by the governing body of the taxing unit;

(4) if the refund is required by Section 31.11, on the
date the auditor for the taxing unit determines that the payment was
erroneous or excessive or, if the amount of the refund exceeds the
applicable amount specified by Section 31.11(a), on the date the

1 governing body of the taxing unit approves the refund;

2 (5) if the refund is required by Section 31.111, on the
3 date the collector for the taxing unit determines that the payment
4 was erroneous; or

5 (6) if the refund is required by Section 31.112, on the
6 date required by Section 31.112(d) or (e), as applicable.

7 SECTION 9. Section 33.08(b), Tax Code, is amended to read as 8 follows:

9 The governing body of the taxing unit or appraisal (b) 10 district, in the manner required by law for official action, may provide that taxes that become delinquent on or after June 1 under 11 Section [26.075(j), 26.15(e), 31.03, 31.031, 31.032, 31.033, 12 31.04, or 42.42 incur an additional penalty to defray costs of 13 14 collection. The amount of the penalty may not exceed the amount of the compensation specified in the applicable contract with an 15 attorney under Section 6.30 to be paid in connection with the 16 17 collection of the delinquent taxes.

18 SECTION 10. Section 49.057, Water Code, is amended by 19 amending Subsection (b) and adding Subsection (j) to read as 20 follows:

(b) The board shall adopt an annual budget. The board of a developed district[, as defined by Section 49.23602,] shall include as an appendix to the budget the district's:

(1) audited financial statements;

25 (2) bond transcripts; and

26 (3) engineer's reports required by Section 49.106.

27 (j) In this section, "developed district" means a district

1 that has financed, completed, and issued bonds to pay for all land, 2 works, improvements, facilities, plants, equipment, and appliances 3 necessary to serve at least 95 percent of the projected build-out of the district in accordance with the purposes for its creation or the 4 purposes authorized by the constitution, this code, or any other 5 6 law. 7 SECTION 11. Section 49.107(g), Water Code, is amended to 8 read as follows: 9 (g) Sections 26.04, [26.042, 26.05, 26.061, and 26.07, 10 [and 26.075,] Tax Code, do not apply to a tax levied and collected under this section or an ad valorem tax levied and collected for the 11 12 payment of the interest on and principal of bonds issued by a 13 district. 14 SECTION 12. Section 49.108(f), Water Code, is amended to 15 read as follows: (f) Sections 26.04, [26.042, 26.05, 26.061, and 26.07, 16 17 [and 26.075,] Tax Code, do not apply to a tax levied and collected for payments made under a contract approved in accordance with this 18 19 section. SECTION 13. Section 49.236(a), Water Code, is amended to 20 read as follows: 21 Before the board adopts an ad valorem tax rate for the 22 (a) district for debt service, operation and maintenance purposes, or 23 contract purposes, the board shall give notice of each meeting of 24 25 the board at which the adoption of a tax rate will be considered. 26 The notice must: 27 (1)contain a statement in substantially the following

1 form:

"NOTICE OF PUBLIC HEARING ON TAX RATE

3 "The (name of the district) will hold a public hearing on a proposed tax rate for the tax year (year of tax levy) on (date and 4 5 time) at (meeting place). Your individual taxes may increase at a greater or lesser rate, or even decrease, depending on the tax rate 6 that is adopted and on the change in the taxable value of your 7 property in relation to the change in taxable value of all other 8 property. The change in the taxable value of your property in 9 10 relation to the change in the taxable value of all other property determines the distribution of the tax burden among all property 11 12 owners.

"Visit Texas.gov/PropertyTaxes to find a link to your local property tax database on which you can easily access information regarding your property taxes, including information about proposed tax rates and scheduled public hearings of each entity that taxes your property.

18 "(Names of all board members and, if a vote was taken, an 19 indication of how each voted on the proposed tax rate and an 20 indication of any absences.)";

(2) contain the following information:

(A) the district's total adopted tax rate for the
preceding year and the proposed tax rate, expressed as an amount per
\$100;

(B) the difference, expressed as an amount per
\$100 and as a percent increase or decrease, as applicable, in the
proposed tax rate compared to the adopted tax rate for the preceding

1 year;

2 (C) the average appraised value of a residence 3 homestead in the district in the preceding year and in the current year; the district's total homestead exemption, other than an 4 5 exemption available only to disabled persons or persons 65 years of age or older, applicable to that appraised value in each of those 6 years; and the average taxable value of a residence homestead in the 7 district in each of those years, disregarding any homestead 8 exemption available only to disabled persons or persons 65 years of 9 10 age or older;

(D) the amount of tax that would have been imposed by the district in the preceding year on a residence homestead appraised at the average appraised value of a residence homestead in that year, disregarding any homestead exemption available only to disabled persons or persons 65 years of age or older;

(E) the amount of tax that would be imposed by the district in the current year on a residence homestead appraised at the average appraised value of a residence homestead in that year, disregarding any homestead exemption available only to disabled persons or persons 65 years of age or older, if the proposed tax rate is adopted;

(F) the difference between the amounts of tax calculated under Paragraphs (D) and (E), expressed in dollars and cents and described as the annual percentage increase or decrease, as applicable, in the tax to be imposed by the district on the average residence homestead in the district in the current year if

1 the proposed tax rate is adopted; and

2 (G) if the proposed combined debt service, 3 operation and maintenance, and contract tax rate requires [or 4 authorizes] an election to approve [or reduce] the tax rate, [as 5 applicable,] a description of the purpose of the proposed tax 6 increase;

7 (3) contain a statement in substantially the following
8 form[, as applicable:

9 [(A) if the district is a district described by
10 Section 49.23601]:

11 "NOTICE OF VOTE ON TAX RATE

"If the district adopts a combined debt service, operation and maintenance, and contract tax rate that would result in the taxes on the average residence homestead increasing <u>from the</u> <u>preceding year</u> [by more than eight percent], an election must be held to determine whether to approve the operation and maintenance tax rate under Section 49.23601, Water Code.";

18 [(B) if the district is a district described by 19 Section 49.23602:

["NOTICE OF VOTE ON TAX RATE

["If the district adopts a combined debt service, operation and maintenance, and contract tax rate that would result in the taxes on the average residence homestead increasing by more than 3.5 percent, an election must be held to determine whether to approve the operation and maintenance tax rate under Section 49.23602, Water Code."; or

[(C) if the district is a district described by

1 Section 49.23603:

["NOTICE OF TAXPAYERS' RIGHT TO ELECTION TO REDUCE TAX RATE 2 3 ["If the district adopts a combined debt service, operation and maintenance, and contract tax rate that would result in the 4 5 taxes on the average residence homestead increasing by more than eight percent, the qualified voters of the district by petition may 6 require that an election be held to determine whether to reduce the 7 8 operation and maintenance tax rate to the voter-approval tax rate under Section 49.23603, Water Code.";] and 9

10 (4) include the following statement: "The 86th Texas 11 Legislature modified the manner in which the voter-approval tax 12 rate is calculated to limit the rate of growth of property taxes in 13 the state.".

SECTION 14. The heading to Section 49.23601, Water Code, is amended to read as follows:

Sec. 49.23601. AUTOMATIC ELECTION TO APPROVE TAX RATE [FOR 17 LOW TAX RATE DISTRICTS].

18 SECTION 15. Sections 49.23601(a) and (c), Water Code, are 19 amended to read as follows:

(a) In this section, "voter-approval tax rate" means therate equal to the sum of the following tax rates for the district:

(1) the current year's debt service tax rate;

) the current year 5 debt service tax rate,

the current year's contract tax rate; and

(3) the operation and maintenance tax rate that would impose [1.08 times] the amount of [the] operation and maintenance tax imposed by the district in the preceding year on a residence homestead appraised at the average appraised value of a residence

1 homestead in the district in that year, disregarding any homestead exemption available only to disabled persons or persons 65 years of 2 3 age or older.

4 (c) If the board of a district adopts a combined debt 5 service, contract, and operation and maintenance tax rate that would impose more than [1.08 times] the amount of tax imposed by the 6 district in the preceding year on a residence homestead appraised 7 8 at the average appraised value of a residence homestead in the district in that year, disregarding any homestead exemption 9 available only to disabled persons or persons 65 years of age or 10 older, an election must be held in accordance with the procedures 11 provided by Sections 26.07(c)-(g), Tax Code, to determine whether 12 to approve the adopted tax rate. If the adopted tax rate is not 13 approved at the election, the district's tax rate is 14 the 15 voter-approval tax rate.
