- WHEREAS, Previously, Sergeant Major Hector Sanchez served as
- 5 Inspector-Instructor First Sergeant for Company C, 1st Battalion,
- 6 23rd Marine Regiment, 4th Marine Division of the Marine Corps
- 7 Forces Reserve in Corpus Christi, Texas; he was assigned to the
- 8 Division in April of 2021, and on September 15, 2023, he was
- 9 transferred to the 1st Battalion, 23rd Marine Regiment at the Naval
- 10 Reserve Center in Houston, Texas, where he assumed his post as
- 11 Inspector-Instructor Sergeant Major, a senior enlisted rank in the
- 12 United States Marines; and
- WHEREAS, Sergeant Major Sanchez joined the U.S. Marine Corps
- 14 in 2004 and was first assigned to Camp Lejeune in North Carolina as
- 15 a military police corrections specialist; in the succeeding years,

- 18 Gunnery Sergeant, and First Sergeant, and in 2012, he was
- 19 transferred to the 1st Law Enforcement Battalion; he deployed to
- 20 Afghanistan in 2013 in support of Operation Enduring Freedom, and
- 21 the following year, he reported to the Marine Security Guard School
- 22 in Quantico, Virginia, where he distinguished himself as an honor
- 23 graduate and high shooter; and
- 24 WHEREAS, After serving as the capital Detachment Commander

- 1 for U.S. consulates in China and Mexico, Sergeant Major Sanchez was
- 2 named senior corrections counselor at Camp Pendleton, California;
- 3 in 2020, he assumed the duties of an Alpha Company First Sergeant,
- 4 preparing his unit for the Southwest Border Mission, and he
- 5 recently helped oversee the mobilization of the 1st Battalion, 23rd
- 6 Marine Regiment in support of Operation Allies Welcome; his awards
- 7 include the U.S. Navy and Marine Corps Commendation Medal and
- 8 Achievement Medal; actively engaged in his community, he has been
- 9 involved with Toys for Tots in Nueces County, among numerous other
- 10 initiatives; and
- 11 WHEREAS, The exceptional leadership demonstrated by Sergeant
- 12 Major Hector Sanchez has greatly benefited the U.S. Marine Corps
- 13 and Company C, and he may indeed reflect with pride on all that he
