1 WHEREAS, Marvin Joe Angle, an esteemed attorney and a valued
2 member of the Jacksonville community, passed away on August 20,
3 2023, at the age of 77; and

4 WHEREAS, The son of Marvin and Pauline Angle, Joe Angle was
5 born in Marshall on September 1, 1945, and he grew up with the
6 companionship of three siblings, Delphine, John, and Donnie; after
7 graduating from Nacogdoches High School in 1963, he received a
8 bachelor's degree in history from Stephen F. Austin State
9 University and a master's degree in history from The University of
10 Texas at Austin; he went on to serve in the U.S. Air Force as a staff
11 sergeant for four years before attending Baylor Law School, where
12 he earned his juris doctor degree in 1976; and

13 WHEREAS, Mr. Angle began his legal career at the Norman Law
14 Firm, and he eventually became a partner; over the years, he
15 developed a successful transactional law practice, and he
16 specialized in the fields of real estate, probate, and estate
17 planning law; he also served as Jacksonville's city attorney,
18 gaining the respect and admiration of his colleagues for his
19 professionalism and integrity; and

20 WHEREAS, Active in his community, Mr. Angle held leadership
21 positions in numerous organizations, including the Jacksonville
22 Rotary Club, the Jacksonville Public Library board, the Cherokee
23 County Bar Association, the Jacksonville High School Band Boosters,
24 the Jacksonville United Fund, Nan Travis Memorial Hospital, and the

1 Cherokee County Republican Party; he was also a scoutmaster for
2 local Scouts BSA troops; a man of deep faith, he served as an elder
3 at Tyler Orthodox Presbyterian Church as well as at several other
4 churches over the years; and

5 WHEREAS, In all his endeavors, Mr. Angle enjoyed the love and
6 support of his wife, Judy, with whom he shared a rewarding marriage
7 that spanned five and a half decades; he took great pride in their
8 children, John and Mary; and

9 WHEREAS, Joe Angle lived a life that was rich in personal and
10 professional achievements, and he will forever be a source of
11 inspiration to those he leaves behind; now, therefore, be it

12 RESOLVED, That the House of Representatives of the 88th Texas
13 Legislature, 3rd Called Session, hereby pay tribute to the memory
14 of Marvin Joe Angle and extend sincere condolences to his loved
15 ones; and, be it further

16 RESOLVED, That an official copy of this resolution be
