5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Section 48.255(b), Education Code, is amended to
7	read as follows:
8	(b) The state compression percentage is the lower of:
9	(1) 93 percent, or a lower percentage set by
10	appropriation for a school year;
11	(2) the percentage determined by the following
12	formula:
13	SCP = PYCP X $1.0 [1.025]/(1 + ECPV)$ ; or
14	(3) the percentage determined under this section for
15	the preceding school year.
16	SECTION 2. Section 48.2551(b), Education Code, is amended
17	to read as follows:

- 19 maximum compressed rate ("MCR") is the lesser of:
- 20 (1) the rate determined by the following [applicable]

- MCR =  $\left[\frac{(1.025)}{(PYDPV+E)} \times PYMCR\right] \left[\frac{1}{2}\right] / DPV$ ; or

- [MCR PYMCR; or]
- 3 (2) the product of the state compression percentage,
- 4 as determined under Section 48.255, for the current tax year,
- 5 multiplied by \$1.00.
- 6 SECTION 3. (a) This section takes effect only if the
- 7 constitutional amendment proposed by H.J.R. 2, 88th Legislature,
- 8 2nd Called Session, 2023, is approved by the voters.
- 9 (b) Section 48.2555(a), Education Code, as effective on
- 10 approval by the voters of H.J.R. 2, 88th Legislature, 2nd Called
- 11 Session, 2023, is amended to read as follows:
- 12 (a) Notwithstanding any other provision of this title or
- 13 Chapter 26, Tax Code, for the 2023-2024 school year, the
- 14 commissioner shall calculate the value of a school district's
- 15 maximum compressed tax rate by determining the district's maximum
- 16 compressed rate under Section 48.2551 [or 48.2552(b), if
- 17 applicable, and reducing the tax rate determined under the
- 18 applicable section by \$0.107.
- SECTION 4. Sections 48.2551(c) and 48.2552, Education Code,
- 20 are repealed.
- 21 SECTION 5. Except as otherwise provided by this Act, this
- 22 Act takes effect September 1, 2024.
