- 18 when he was also named a first-team All-American; following his
- 19 collegiate career, he played for the Ottawa Rough Riders in the
- 20 Canadian Football League for two seasons and in the Arena Football
- 21 League for five seasons; he was inducted into the Texas Tech
- 22 Athletics Hall of Fame in 2002 and the Texas High School Football
- 23 Hall of Fame in 2020; and
- 24 WHEREAS, Through his dedicated efforts, Tyrone Thurman has
