## RESOLUTION

- 1 WHEREAS, Lavinia Masters is being inducted into the Texas
- 2 Women's Hall of Fame on November 9, 2023, by Governor Greg Abbott
- 3 and the Governor's Commission for Women; and
- WHEREAS, Recognized for her advocacy and community service,
- 5 Ms. Masters is the namesake of the Lavinia Masters Act; this
- 6 important legislation requires that law enforcement agencies test
- 7 evidence collected after sexual assaults in a timely manner and
- 8 extends the statute of limitations for cases with untested
- 9 evidence; and
- 10 WHEREAS, When she was only 13 years old, Ms. Masters
- 11 experienced the trauma of sexual assault and the further trauma of a
- 12 dehumanizing and ineffective system of justice for victims; she
- 13 relied on a foundation of faith and family to gradually heal, and as
- 14 an adult, she began to use her voice in behalf of other survivors;
- 15 and
- WHEREAS, In 2005, Ms. Masters became a leader in the national
- 17 effort to eliminate the backlog in processing rape kits; at a news
- 18 conference with the Dallas Police Department, she urged other
- 19 survivors to come forward and request that their evidence be
- 20 examined; she testified before the Texas Legislature and the
- 21 U.S. Congress and spoke to numerous news outlets; recognizing that
- 22 the issue was international, she even addressed audiences abroad;
- 23 and
- 24 WHEREAS, Ms. Masters joined forces with state legislators in

- 1 2017 to pursue action on the matter; she served on a sexual assault
- 2 task force and worked tirelessly to raise awareness of the need for
- 3 such legislation; when House Bill 8 was passed in 2019, it was
- 4 fittingly named in her honor; and
- 5 WHEREAS, Today, as an activist, author, public speaker, and
- 6 consultant, Ms. Masters encourages others to embrace purposeful
- 7 living after trauma and speak out; she is also a coach for members
- 8 of the entertainment industry seeking to remain trauma-informed and
- 9 survivor-centered; the founder and director of Hope S.A.V.E.S., she
- 10 has given generously of her time and expertise as a member of many
- 11 organizations, among them the boards of the Turning Point Rape
- 12 Crisis Center and the Governor's Sexual Assault Survivors' Task
- 13 Force; and
- WHEREAS, Lavinia Masters has inspired innumerable people by
- 15 effecting positive change and empowering them to do likewise, and
- 16 she is richly deserving of this prestigious accolade; now,
- 17 therefore, be it
- 18 RESOLVED, That the House of Representatives of the 88th Texas
- 19 Legislature, 4th Called Session, hereby congratulate Lavinia
- 20 Masters on her induction into the Texas Women's Hall of Fame and
- 21 extend to her sincere best wishes for continued success in her
- 22 endeavors; and, be it further

- 24 prepared for Ms. Masters as an expression of high regard by the
- 25 Texas House of Representatives.
