- 22 University of Texas at Austin, a master's degree in education from
- 23 Hardin-Simmons University, and a doctorate in education from the
- 24 University of North Texas; she began her career as a math teacher in

- 1 San Angelo ISD, where she also served as an elementary and high
- 2 school counselor, and she later served as an adjunct instructor at
- 3 UNT; and

- 6 spirit that are the hallmarks of our best educators, and the naming
- 7 of the district administration building in her honor is a fitting
