1           WHEREAS, Residents of Cedar Hill lost an admired civic leader  
2 with the passing of Monica M. Kenney on November 18, 2023, at the  
3 age of 53; and

4           WHEREAS, Born in Marshall on November 29, 1969, to Jiles  
5 Kenney Jr. and Laverne Kenney, Monica Kenney grew up with the  
6 companionship of a younger sister, Vanessa; she graduated with  
7 honors from Skyline High School in Dallas before attending Cedar  
8 Valley College; her career in banking included work at Chase Bank  
9 and Frost Bank, where she rose to the position of senior vice  
10 president of commercial lending; as one of the most prominent  
11 African American women in her field in the Dallas/Fort Worth  
12 Metroplex, she was often invited to share her knowledge and  
13 expertise through speaking engagements and participation on  
14 panels; and

15           WHEREAS, Actively involved in her community, Ms. Kenney  
16 generously contributed to organizations such as the Best Southwest  
17 Partnership, Leadership Southwest, and several local chambers of  
18 commerce; she was a firm believer in the importance of education,  
19 which led to her serving the Cedar Hill Independent School District  
20 Education Foundation as president, as vice president of  
21 development, and in other roles; and

22           WHEREAS, Above all else, Ms. Kenney was devoted to her three  
23 children, Rhyan, Christian, and Courtney, who were the light of her  
24 life; she also cherished her nieces, nephews, and extended family,

1 and she always went above and beyond to help her loved ones; and

2 WHEREAS, Although Monica Kenney is deeply missed, she will  
3 forever be remembered with admiration and affection by her  
4 treasured family and by the numerous other individuals whose lives  
5 she touched; now, therefore, be it

6 RESOLVED, That the House of Representatives of the 88th Texas  
7 Legislature, 4th Called Session, hereby pay tribute to the memory  
8 of Monica M. Kenney and extend heartfelt sympathy to the members of
