A BILL TO BE ENTITLED

AN ACT

2 relating to early voting by mail by any qualified voter and to the 3 repeal of certain criminal offenses concerning the solicitation and 4 distribution of an application to vote by mail.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Section 13.002(e), Election Code, is amended to 7 read as follows:

Notwithstanding Section 82.005, a [A] person who is 8 (e) 9 certified for participation in the address confidentiality program administered by the attorney general under Subchapter B, Chapter 10 11 58, Code of Criminal Procedure, is not eligible for early voting by 12 mail [under Section 82.007] unless the person submits an application under this section by personal delivery. The secretary 13 of state may adopt rules to implement this subsection. 14

15 SECTION 2. Section 82.005, Election Code, is amended to 16 read as follows:

Sec. 82.005. ELIGIBILITY FOR EARLY VOTING [BY PERSONAL APPEARANCE]. Any qualified voter is eligible for early voting by <u>mail or personal appearance.</u>

20 SECTION 3. Section 82.007, Election Code, is amended to 21 read as follows:

22 Sec. 82.007. PARTICIPATION IN ADDRESS CONFIDENTIALITY 23 PROGRAM. <u>Notwithstanding Section 82.005, a</u> [A] qualified voter 24 who, [is eligible for early voting by mail if:

[(1) the voter submitted a registration application by
 personal delivery as required by Section 13.002(e); and

3 $[\frac{(2)}{(2)}]$ at the time the voter's early voting ballot application is submitted, [the__voter] is certified 4 for participation in the address confidentiality program administered 5 by the attorney general under Subchapter B, Chapter 58, Code of 6 Criminal Procedure, is eligible for early voting by mail only if the 7 8 voter submitted a registration application by personal delivery as required by Section 13.002(e). 9

10 SECTION 4. Section 84.001(a), Election Code, is amended to 11 read as follows:

12 (a) To be entitled to vote an early voting ballot by mail, a 13 person [who is eligible for early voting] must make an application 14 for an early voting ballot to be voted by mail as provided by this 15 title.

16 SECTION 5. Section 84.002(a), Election Code, is amended to 17 read as follows:

18 (a) An early voting ballot application must include:

19 (1) the applicant's name and the address at which the20 applicant is registered to vote;

21

(1-a) the following information:

(A) the number of the applicant's driver's
 license, election identification certificate, or personal
 identification card issued by the Department of Public Safety;

(B) if the applicant has not been issued a number
described by Paragraph (A), the last four digits of the applicant's
social security number; or

1 (C) a statement by the applicant that the 2 applicant has not been issued a number described by Paragraph (A) or 3 (B);

4 (2) for an application for a ballot to be voted by mail
5 by an applicant who will be absent from the applicant's [on the
6 ground of absence from the] county of residence on election day, the
7 address outside the applicant's county of residence to which the
8 ballot is to be mailed;

9 (3) for an application for a ballot to be voted by mail by an applicant who is 65 years of age or older on election day or 10 has a sickness or physical condition that requires the applicant to 11 12 reside in a hospital or nursing home or other long-term care facility, or with a relative [on the ground of age or disability], 13 14 the address of the hospital, nursing home or other long-term care facility, or retirement center, or of a person related to the 15 applicant within the second degree by affinity or the third degree 16 17 by consanguinity, as determined under Chapter 573, Government Code, if the applicant is living at that address and that address is 18 19 different from the address at which the applicant is registered to vote; 20

(4) for an application for a ballot to be voted by mail by an applicant who is confined [on the ground of confinement] in jail as described by Section 84.009(a), the address of the jail or of a person related to the applicant within the degree described by Subdivision (3);

26 (5) [for an application for a ballot to be voted by 27 mail on any ground,] an indication of each election for which the

1 applicant is applying for a ballot; and 2 (6) [an indication of the ground of eligibility for 3 early voting; and 4 $\left[\frac{(7)}{7}\right]$ for an application for a ballot to be voted by mail by an applicant who is civilly committed as a sexually violent 5 predator under Chapter 841, Health and Safety Code, and is ordered 6 7 as a condition of civil commitment to reside in a facility operated 8 by or under contract with the Texas Civil Commitment Office [on the ground of involuntary civil commitment], the address of the 9 facility operated by or under contract with the Texas Civil 10 Commitment Office or of a person related to the applicant within the 11 degree of consanguinity described by Subdivision (3). 12 SECTION 6. Section 84.009, Election Code, is amended by 13 14 amending Subsection (a) and adding Subsection (b) to read as 15 follows: 16 This section applies only to an applicant who, at the (a) 17 time the application for a ballot to be voted by mail is submitted, is confined in jail: 18 19 (1) serving a misdemeanor sentence for a term that ends on or after election day; 20 21 (2) pending trial after denial of bail; (3) without bail pending an appeal of a felony 22 23 conviction; or 24 (4) pending trial or appeal on a bailable offense for which release on bail before election day is unlikely. 25 26 (b) On request of the applicant, an application for a ballot to be voted by mail [on the ground of confinement in jail] may be 27

No. 67 submitted to the early voting clerk, at the discretion of the 1 authority in charge of the jail, by personal delivery by the jail 2 3 authority or by a designated subordinate of the authority. 4 SECTION 7. Section 84.011(a), Election Code, is amended to 5 read as follows: (a) The officially prescribed application form for an early 6 7 voting ballot must include: 8 (1)immediately preceding the signature space the statement: certify that the information given in this "Ι 9 10 application is true, and I understand that giving false information in this application is a crime."; 11 12 (2) a statement informing the applicant of the offenses prescribed by Sections 84.003 and 84.004; 13 14 (3) spaces for entering an applicant's voter 15 registration number and county election precinct of registration, with a statement informing the applicant that failure to furnish 16 17 that information does not invalidate the application; (3-a) a space for entering the information required 18 under Section 84.002(a)(1-a); and 19 (4) on an application for a ballot to be voted by mail: 20 21 (A) a space for an applicant [applying on the ground of absence from the county of residence] to indicate whether 22 the applicant will be absent from the applicant's county of 23 24 residence on election day and, if applicable, the date on or after which the applicant can receive mail at the address outside the 25 26 county; 27 (B) a space for indicating the fact that

1 applicant whose application is signed by a witness cannot make the 2 applicant's mark and a space for indicating the relationship or 3 lack of relationship of the witness to the applicant;

4 (C) a space for entering an applicant's telephone 5 number, with a statement informing the applicant that failure to 6 furnish that information does not invalidate the application;

7 a space or box for an applicant who is 65 (D) 8 years of age or older on election day or has a sickness or physical condition that requires the applicant to reside in a hospital or 9 nursing home or other long-term care facility, or with a relative, 10 [applying on the ground of age or disability] to indicate that the 11 12 address to which the ballot is to be mailed is the address of a facility or relative described by Section 84.002(a)(3), 13 if 14 applicable;

15 (E) a space or box for an applicant who is confined [applying on the ground of confinement] in jail as 16 described by Section 84.009(a) or who is civilly committed as a 17 sexually violent predator under Chapter 841, Health and Safety 18 19 Code, and ordered as a condition of civil commitment to reside in a facility operated by or under contract with the Texas Civil 20 Commitment Office, [involuntary civil commitment] to indicate that 21 the address to which the ballot is to be mailed is the address of a 22 relative described by Section 84.002(a)(4) or <u>(6)</u> [(7)], if 23 24 applicable;

(F) a space for an applicant [applying on the ground of age or disability] to indicate if the application is an application under Section 86.0015;

(G) spaces for entering the signature, printed
 name, and residence address of any person assisting the applicant;

3 (H) a statement informing the applicant of the4 condition prescribed by Section 81.005; and

5 (I) a statement informing the applicant of the 6 requirement prescribed by Section 86.003(c).

7 SECTION 8. Sections 86.001(b) and (c), Election Code, are 8 amended to read as follows:

9 (b) If the <u>application complies with the applicable</u> 10 <u>requirements prescribed by this title</u> [applicant is entitled to 11 vote an early voting ballot by mail], the clerk shall provide an 12 official ballot to the applicant as provided by this chapter.

(c) Except as provided by Section 86.008, if the applicant is not entitled to vote <u>in the election</u> [by mail], the clerk shall reject the application, enter on the application "rejected" and the reason for and date of rejection, and deliver written notice of the reason for the rejection to the applicant at both the residence address and mailing address on the application. A ballot may not be provided to an applicant whose application is rejected.

20 SECTION 9. Section 86.0015(a), Election Code, is amended to 21 read as follows:

(a) This section applies only to an application for a ballot
to be voted by mail that [+

24 [(1) indicates the ground of eligibility is age or 25 disability; and

26 [(2)] does not specify the election for which a ballot
27 is requested or has been marked by the applicant as an application

1 for more than one election.

2 SECTION 10. Section 86.003(c), Election Code, is amended to 3 read as follows:

4 (c) The address to which the balloting materials must be
5 addressed is the address at which the voter is registered to vote,
6 or the registered mailing address if different, unless the
7 application to vote early by mail indicates that the voter [ground
8 for voting by mail is]:

9 (1) <u>will be absent from the voter's</u> [absence from the] 10 county of residence <u>on election day</u>, in which case the address must 11 be an address outside the voter's county of residence;

12 (2) <u>is confined</u> [confinement] in jail <u>as described by</u> 13 <u>Section 84.009(a)</u>, in which case the address must be the address of 14 the jail or of a relative described by Section 84.002(a)(4);

15 (3) is 65 years of age or older on election day or has a sickness or physical condition that requires the applicant to 16 17 reside in a hospital or nursing home or other long-term care facility, or with a relative, [age or disability] and [the voter] is 18 19 living at a hospital, nursing home or other long-term care facility, or retirement center, or with a relative described by 20 Section 84.002(a)(3), in which case the address must be the address 21 of that facility or relative; or 22

(4) <u>is civilly committed as a sexually violent</u> predator under Chapter 841, Health and Safety Code, and ordered as a condition of civil commitment to reside in a facility operated by or under contract with the Texas Civil Commitment Office [involuntary civil commitment], in which case the address must be the address of

1 the facility or of a relative described by Section <u>84.002(a)(6)</u>
2 [<u>84.002(a)(7)</u>].

3 SECTION 11. Section 86.004(b), Election Code, is amended to 4 read as follows:

5 (b) For an election to which Section 101.104 applies, the balloting materials for a voter who indicates on the application 6 for a ballot to be voted by mail or the federal postcard application 7 8 that the voter seeks [is eligible] to vote early by mail as a consequence of the voter's being outside the United States shall be 9 mailed on or before the later of the 45th day before election day or 10 the seventh calendar day after the date the clerk receives the 11 application. However, if it is not possible to mail the ballots by 12 the deadline of the 45th day before election day, the clerk shall 13 14 notify the secretary of state within 24 hours of knowing that the 15 deadline will not be met. The secretary of state shall monitor the situation and advise the clerk, who shall mail the ballots as soon 16 17 as possible in accordance with the secretary of state's guidelines.

18 SECTION 12. Section 87.041(b), Election Code, is amended to 19 read as follows:

20

(b) A ballot may be accepted only if:

21 (1) the carrier envelope certificate is properly 22 executed;

(2) neither the voter's signature on the ballot application nor the signature on the carrier envelope certificate is determined to have been executed by a person other than the voter, unless signed by a witness;

(3) [the voter's ballot application states a legal

1 ground for early voting by mail;

2 [(4)] the voter is registered to vote, if registration
3 is required by law;

4 <u>(4)</u> [(5) the address to which the ballot was mailed 5 to the voter, as indicated by the application, was outside the 6 voter's county of residence, if the ground for early voting is 7 absence from the county of residence;

8 [(6)] for a voter to whom a statement of residence form 9 was required to be sent under Section 86.002(a), the statement of 10 residence is returned in the carrier envelope and indicates that 11 the voter satisfies the residence requirements prescribed by 12 Section 63.0011;

13 (5) [(7)] the address to which the ballot was mailed 14 to the voter is an address [that is otherwise] required by Sections 15 84.002 and 86.003; and

16 (6) [(8)] the information required under Section 17 86.002(g) provided by the voter identifies the same voter 18 identified on the voter's application for voter registration under 19 Section 13.002(c)(8).

20 SECTION 13. Section 102.001(a), Election Code, is amended 21 to read as follows:

(a) A qualified voter is eligible to vote a late ballot as provided by this chapter if the voter has a sickness or physical condition [described by Section 82.002] that prevents the voter from appearing at the polling place on election day without a likelihood of needing personal assistance or of injuring the voter's health and originates on or after the day before the last

14	SECTION 15. The changes in law made by this Act apply only
15	to an election ordered on or after September 1, 2023.
16	SECTION 16. This Act takes effect September 1, 2023.
