## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the provision of certain co-navigation services to
3	individuals who are deaf-blind.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 81.001, Human Resources Code, is amended
6	by adding Subdivision (1) to read as follows:
7	(1) "Commission" means the Health and Human Services
8	Commission.
9	SECTION 2. Chapter 81, Human Resources Code, is amended by
10	adding Section 81.014 to read as follows:
11	Sec. 81.014. CO-NAVIGATION SERVICES PROGRAM FOR
12	INDIVIDUALS WHO ARE DEAF-BLIND. (a) In this section:
13	(1) "Communication mode" includes communication
14	through:
15	(A) auditory amplification, such as through a
16	personal hearing aid or assistive listening device;
17	(B) American Sign Language or Signed English by
18	both tactile and visual means; and
19	(C) protactile language.
20	(2) "Co-navigation services" means services provided
21	to an individual who is deaf-blind that assist the individual to
22	physically access the individual's environment and to make informed
23	decisions. The term includes providing visual and environmental
24	information or sighted guide services and assisting with

H.B. No. 140 communication accessibility by communicating in the preferred 1 2 language and communication mode of the individual who is deaf-blind. The term does not include performing any of the 3 following for the individual: 4 5 (A) providing personal care services to the 6 individual; 7 (B) completing ordinary errands for the 8 individual; 9 (C) making decisions for the individual; (D) teaching or otherwise instructing the 10 11 individual; or 12 (E) interpreting for the individual in a formal setting, including a medical, legal, or business setting. 13 (3) "Co-navigator" means a person who is specially 14 15 trained to provide co-navigation services. 16 (4) "Program" means the deaf-blind co-navigation 17 services program. (5) "Protactile language" means a method 18 of 19 communication based on touch that is used by individuals who are deaf-blind. 20 21 (b) The commission shall operate a statewide co-navigation 22 services program through which: 23 (1) co-navigation services are provided by 24 co-navigators; and 25 (2) the commission reimburses the co-navigators for 26 the provision of the services. 27 (c) The executive commissioner by rule shall establish

1 reimbursement rates to be paid to a co-navigator under the program. The reimbursement rates must use a tiered wage scale that is based 2 3 on the co-navigator's: 4 (1) level of training in communication modes for 5 individuals who are deaf-blind and in sighted guide-mobility 6 techniques; and 7 (2) fluency and skill in communication modes and 8 sighted guide-mobility for individuals who are deaf-blind. 9 The commission shall ensure that quality co-navigation (d) 10 services are provided under the program by: (1) monitoring the compliance of co-navigators with 11 12 program rules; 13 (2) developing funding sources for the program that 14 are in addition to state sources and will reduce reliance on the 15 state sources for continuation of the program; and 16 (3) providing funding and technical assistance for 17 training programs for: 18 (A) co-navigators under the program; and 19 (B) individuals who are deaf-blind to enable those individuals to effectively use the services offered under the 20 21 program. 22 (e) The executive commissioner may establish an advisory committee to advise the commission in developing and operating the 23 24 program, including operating the program in a manner that ensures the efficient use of state money. Subject to Section 2110.002, 25 26 Government Code, the executive commissioner shall determine the number of members serving on the advisory committee, which must 27

include individuals who are deaf-blind and other stakeholders.
(f) The executive commissioner may adopt rules necessary
to:
(1) operate the program in a manner that is efficient
and maximizes the number of individuals served; and
(2) ensure that co-navigators receiving reimbursement
under the program have adequate training to provide co-navigation
services.
SECTION 3. Not later than September 1, 2024:
(1) the executive commissioner of the Health and Human
Services Commission shall adopt rules necessary to implement
Section 81.014, Human Resources Code, as added by this Act; and
(2) the commission shall begin operating the program
required by that section.
SECTION 4. This Act takes effect September 1, 2023.
