- 1 (c) The comptroller shall designate seven consecutive days in January and seven consecutive days in August of each year during 2 which the exemption authorized by this section is effective. The 3 comptroller shall designate each exemption period for the time in 4 5 the relevant month when the greatest number of books described by Subsection (b) is likely to be purchased, as determined by the 6 comptroller based on a review of the academic calendars of 7 institutions of higher education and colleges and universities 8 described by Subsection (b)(1). The comptroller shall designate the 9 exemption period in a manner and at a time that provides reasonable 10 notice of the exemption period to retailers and the public. 11
- 12 (d) A person may establish that the person is a full-time or
  13 part-time student by presenting a valid student identification
  14 card. The comptroller by rule shall prescribe the manner by which a
  15 person making an online purchase may electronically establish that
  16 the person is a full-time or part-time student.
- SECTION 2. The change in law made by this Act does not affect taxes imposed before the effective date of this Act, and the law in effect before the effective date of this Act is continued in effect for purposes of the liability for and collection of those taxes.
- SECTION 3. This Act takes effect July 1, 2023, if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution.

  If this Act does not receive the vote necessary for effect on that date, this Act takes effect October 1, 2023.
