5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle I, Title 4, Government Code, is amended
7	by adding Chapter 540 to read as follows:
8	CHAPTER 540. FEDERAL WAIVER TO EXPAND MEDICAID IN CERTAIN COUNTIES
9	Sec. 540.0001. DEFINITION. Notwithstanding Section
10	531.001, in this chapter, "Medicaid" means the medical assistance
11	program established under Title XIX, Social Security Act (42 U.S.C.
12	Section 1396 et seq.).
13	Sec. 540.0002. FEDERAL AUTHORIZATION FOR MEDICAL
14	EXPANSION IN CERTAIN COUNTIES. (a) On a county's request and
15	notwithstanding any other law, the executive commissioner shall, or
16	the county's behalf, seek a waiver under Section 1115 of the Social
17	Security Act (42 U.S.C. Section 1315) to the state Medicaid plan to
18	expand the categories of individuals eligible for Medicaid benefits
19	by allowing the county to provide Medicaid benefits to any resident
20	of the county:
21	(1) who is not otherwise eligible to receive Medicaid
22	benefits under the program established under Chapter 32, Human
23	Resources Code, and operated by this state, including through a

waiver, other than a waiver sought under this section, to the

- 1 program;
- 2 (2) who applies to receive Medicaid benefits; and
- 3 (3) for whom federal matching funds are available
- 4 under the Patient Protection and Affordable Care Act (Pub. L. No.
- 5 111-148) as amended by the Health Care and Education Reconciliation
- 6 Act of 2010 (Pub. L. No. 111-152) to provide Medicaid benefits.
- 7 (b) The terms of a waiver under this section must:
- 8 (1) specify how, and with the assistance of what
- 9 entities, the county will implement and operate a delivery system
- 10 for the provision of Medicaid benefits to individuals described by
- 11 Subsection (a);
- 12 (2) specify the commission's role in facilitating the
- 13 provision of those Medicaid benefits;
- 14 (3) identify the sources of money to be used to pay
- 15 this state's share of the cost of Medicaid benefits the county
- 16 provides;
- 17 (4) establish qualifications for an individual to be
- 18 considered a resident of the county for purposes of receiving
- 19 Medicaid benefits from the county; and
- 20 <u>(5) if appropriate, prescribe changes to</u> the
- 21 <u>commission's eligibility determination process for Medicaid</u>
- 22 benefits to accommodate the expanded categories of individuals
- 23 <u>eligible to receive Medicaid benefits from the county.</u>
- 24 (c) The executive commissioner shall adopt rules necessary
- 25 to implement this section.
- SECTION 2. Not later than December 1, 2023, the executive
- 27 commissioner of the Health and Human Services Commission shall

- 1 adopt rules necessary to implement Section 540.0002, Government
- 2 Code, as added by this Act, including rules that specify procedures
- 3 by which a county may request that the executive commissioner seek a
- 4 waiver under that section.
- 5 SECTION 3. This Act takes effect immediately if it receives
- 6 a vote of two-thirds of all the members elected to each house, as
- 7 provided by Section 39, Article III, Texas Constitution. If this
- 8 Act does not receive the vote necessary for immediate effect, this
- 9 Act takes effect September 1, 2023.
