| 15 | as they relate to the history of African Americans. |
| 16 | (c) The board is composed of 15 members appointed by the |
| 17 | State Board of Education as follows: |
| 18 | (1) 10 members who are academic professionals with |
| 19 | expertise in African American studies and who have served to |
| 20 | actively educate the public on the impact of the enslavement era, |
| 21 | the contributions of African Americans to society, and racial |
| 22 | equity issues, including: |
| 23 | (A) five members who are: |
| 24 | (i) faculty and staff members representing |

1 including at least: 2 (i) one member recommended by a statewide 3 organization focused on research-based education policy; and 4 (ii) one member recommended by an advocacy 5 organization that works with parents of students. 6 (d) Not later than November 1 of each year, the State Board 7 of Education shall solicit and review recommendations and make 8 final appointments to the board in accordance with Subsection (c). 9 Members of the board serve staggered two-year terms, (e) with the terms of five members expiring on December 1 of each year. 10 Members may be reappointed at the end of a term for up to four terms. 11 12 (f) The members of the board shall elect a presiding officer for the board. The board shall hold meetings at the call of the 13 14 presiding officer. 15 (g) The board shall: 16 (1) advise and provide recommendations to the State 17 Board of Education and the agency on curriculum and guidance related to African American history and culture; and 18 19 (2) review and propose changes to interdisciplinary content that references African American history and culture, 20 21 including textbooks, for kindergarten through grade 12. (h) Not later than December 1 of each year, the board shall 22 prepare and submit to the governor, the legislature, the agency, 23 24 and the State Board of Education a written report that includes: 25 (1) a summary of the board's work throughout the year; 26 (2) any information provided to the State Board of 27 Education and the agency under Subsection (g); and
