A BILL TO BE ENTITLED 1 AN ACT 2 relating to innovation grant programs to support residency training programs in psychiatric specialty fields and recruitment, 3 training, and retention programs in behavioral health fields. 4 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Chapter 58A, Education Code, is amended by 6 adding Subchapter D to read as follows: 7 SUBCHAPTER D. PSYCHIATRIC SPECIALTY INNOVATION GRANT PROGRAM 8 Sec. 58A.071. PSYCHIATRIC SPECIALTY INNOVATION GRANT 9 PROGRAM. Subject to available funds, the board shall establish an 10 innovation grant program under which the board awards incentive 11 12 payments to medical schools that administer innovative residency training programs designed to increase the number of physicians in 13 14 this state who specialize in pediatric or adult psychiatric care. Sec. 58A.072. FEDERAL FUNDS AND GIFTS, GRANTS, AND 15 16 DONATIONS. In addition to other money appropriated by the legislature, for the purpose of promoting pediatric or adult 17 psychiatric care under the program established under this 18 19 subchapter the board may: 20 (1) seek and apply for any available federal funds; 21 and 22 (2) solicit and accept gifts, grants, and donations 23 from any other source, public or private, as necessary to ensure 24 effective implementation of the program.

FEDERAL FUNDS AND GIFTS, GRANTS, AND 5 DONATIONS. In addition to other money appropriated by the legislature, for the purpose of increasing the behavioral health 6 7 workforce in this state under the program established under this 8 subchapter the board may: 9 (1) seek and apply for any available federal funds; 10 and (2) solicit and accept gifts, grants, and donations 11 12 from any other source, public or private, as necessary to ensure effective implementation of the program. 13 Sec. 61.9993. RULES. (a) The board shall adopt rules for 14 15 the administration of the program established under this subchapter. In adopting the rules, the board shall solicit from the 16 17 Texas Behavioral Health Executive Council information necessary to identify programs anticipated to produce the best outcomes and 18 19 serve the greatest need. Sec. 61.9997. ADMINISTRATIVE COSTS. A reasonable amount, 18 19 not to exceed five percent, of any general revenue appropriated for purposes of this subchapter may be used by the board to pay the 20 costs of administering this subchapter. 21 SECTION 3. (a) As soon as practicable after the effective 22 date of this Act, the Texas Higher Education Coordinating Board 23 24 shall adopt rules for the implementation and administration of the innovation grant programs established under Subchapter D, Chapter 25

26 58A, Education Code, and Subchapter RR, Chapter 61, Education Code, 27 as added by this Act.

1 (b) Not later than September 1, 2024, the Texas Higher 2 Education Coordinating Board shall establish the innovation grant 3 programs required by Subchapter D, Chapter 58A, Education Code, and 4 Subchapter RR, Chapter 61, Education Code, as added by this Act, and 5 shall begin to award grants under each program as soon as 6 practicable after the program is established.

7 SECTION 4. This Act takes effect September 1, 2023.
