CERTAIN EXEMPTIONS FROM CONVICTIONS. 7 А person is not convicted, as that term is defined by Section 411.171, 8 9 if an order of deferred adjudication was entered against the person on a date not less than 10 years preceding the date of the person's 10 application for a license under this subchapter unless the order of 11 12 deferred adjudication was entered against the person for: (1) 13 a felony offense under: 14 (A) Title 5, Penal Code; Section 29.03 [Chapter 29], Penal Code; 15 (B) Section 25.07 or 25.072, Penal Code; or 16 (C) Section 30.02, Penal Code, if the offense is 17 (D) punishable under Subsection [(c)(2) or] (d) of that section; or 18 (2) an offense under the laws of another state if the 19 offense contains elements that are substantially similar to the 20 21 elements of an offense listed in Subdivision (1). 22 SECTION 2. The change in law made by this Act applies to any 23 determination of a person's eligibility for a license to carry a handgun under Subchapter H, Chapter 411, Government Code, that is 24
