The full report and detailed findings of the autopsy, 11 12 if any, shall be a part of the record. Copies of all records shall promptly be delivered to the proper district, county, or criminal 13 14 district attorney in any case where further investigation is advisable. The records may not be withheld, subject to a 15 16 discretionary exception under Chapter 552, Government Code, and except as provided by Subsection (b). 17 18 (b) A [that a] photograph or x-ray of a body taken during an autopsy is excepted from required public disclosure in accordance 19 with Chapter 552, Government Code, but is subject to disclosure: 20 21 (1) under a subpoena or authority of other law; [or] 22 if the photograph or x-ray is of the body of a (2) person who died while in the custody of law enforcement; or 23

<u>deceased</u>, subject to a discretionary exception under Chapter 552, <u>Government Code</u>.

3 (b-1) [(b)] Under the exception to public disclosure provided by Subsection (b) [(a)], a governmental body as defined by 4 5 Section 552.003, Government Code, may withhold a photograph or x-ray described by that subsection [Subsection (a)] without 6 requesting a decision from the attorney general under Subchapter G, 7 8 Chapter 552, Government Code. This subsection does not affect the required disclosure of a photograph or x-ray as otherwise required 9 by [under] Subsection (b) [(a)(1) or (2)]. 10

11 (b-2) A release of a photograph or x-ray described by 12 Subsection (b) is not considered a release of information to the 13 public for purposes of Section 552.007, Government Code, and does 14 not waive the right to assert in the future that the photograph or 15 x-ray is excepted from required disclosure under this section or 16 other law.

SECTION 2. The changes in law made by this Act apply only to a request for information that is received by a governmental body or an officer for public information on or after the effective date of this Act. A request for information that was received before the effective date of this Act is governed by the law in effect on the date the request was received, and the former law is continued in effect for that purpose.
