1	AN ACT
2	relating to a statewide disaster alert system.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Chapter 418, Government Code, is amended by
5	adding Subchapter L to read as follows:
6	SUBCHAPTER L. STATEWIDE DISASTER ALERT SYSTEM
7	Sec. 418.451. DEFINITION. In this subchapter, "alert
8	system" means the statewide disaster alert system developed and
9	implemented under this subchapter.
10	Sec. 418.452. ESTABLISHMENT OF ALERT SYSTEM. (a) With the
11	cooperation of the office of the governor and appropriate state
12	agencies, the division shall develop and implement a statewide
13	alert system to activate in the event of a disaster affecting any
14	location in this state.
15	(b) The alert system may be operated in conjunction with any
16	other emergency alert system required by federal or state law. The
17	alert system must notify persons statewide of a disaster affecting
18	any location in this state. The notification must be provided
19	through:
20	(1) public and commercial television or radio
21	broadcasts;
22	(2) a system of dynamic message signs located across
23	this state; and
24	(3) reverse 9-1-1 telephone calls, text messages,

- 1 e-mails, social media, and other instant messaging systems.
- 2 (c) The division shall allow persons to register for a
- 3 preferred method of receiving the notification described by
- 4 Subsection (b)(3).
- 5 Sec. 418.453. ACTIVATION OF ALERT SYSTEM. (a) When the
- 6 <u>division determines that a disaster has occurred or that the</u>
- 7 occurrence or threat of disaster is imminent or is notified of a
- 8 declaration of disaster under this chapter, the division shall
- 9 immediately activate the alert system.
- 10 (b) The division shall issue updated notifications for the
- 11 duration of the disaster.
- 12 Sec. 418.454. CONTENT OF ALERT SYSTEM NOTIFICATION. (a) A
- 13 notification issued under the alert system must include all
- 14 information necessary to:
- (1) assist a person affected by the disaster with
- 16 making informed decisions regarding the person's safety; and
- 17 (2) enable a person in another location in this state
- 18 to assist an affected person.
- 19 (b) The notification must include:
- 20 (1) real-time information regarding the availability
- 21 of gas, food, lodging, 24-hour pharmacy services, and medical care
- 22 and the disposition of a deceased individual;
- 23 (2) for a hurricane, the category classification of
- 24 the hurricane, including updated information on changes in the
- 25 category classification, the expected time and location of
- 26 landfall, and other detailed information; and
- 27 (3) other information the division determines

- 1 appropriate.
- 2 Sec. 418.455. TERMINATION OF ALERT SYSTEM. The division
- 3 shall terminate the activation of the alert system when:
- 4 (1) the division determines that:
- 5 (A) the threat or danger has passed; or
- 6 (B) the disaster has been addressed to the extent
- 7 that emergency conditions no longer exist; or
- 8 (2) the state of disaster is terminated as provided by
- 9 this chapter.
- 10 SECTION 2. As soon as practicable after the effective date
- 11 of this Act, the Texas Division of Emergency Management shall
- 12 implement Subchapter L, Chapter 418, Government Code, as added by
- 13 this Act.
- 14 SECTION 3. This Act takes effect immediately if it receives
- 15 a vote of two-thirds of all the members elected to each house, as
- 16 provided by Section 39, Article III, Texas Constitution. If this
- 17 Act does not receive the vote necessary for immediate effect, this
- 18 Act takes effect September 1, 2023.
