In this subchapter: 7 (1) "Enrollee" means an individual who is enrolled in 8 9 a health benefit plan or otherwise entitled to coverage under a health benefit plan. 10 11 (2) "Health benefit plan" means an individual, group, blanket, or franchise insurance policy, a group hospital service 12 contract, or an individual or group subscriber contract or evidence 13 of coverage issued by a health maintenance organization, that 14 provides benefits for health care services. 15 16 (3) "Health care provider" means a person who provides health care services under a license, certificate, registration, or 17 other similar evidence of regulation issued by this or another 18 19 state of the United States. 20 (4) "Health care service" means a service to diagnose, prevent, alleviate, cure, or heal a human illness or injury that is 21 22 provided to an individual by a physician or other health care 23 provider. 24 (5) "Physician" means an individual licensed to

2	Sec. 1204.302. APPLICABILITY TO CERTAIN PLANS. In addition
3	to the health benefit plans described by Section 1204.301,
4	notwithstanding any other law, this subchapter applies to:

7	(3) a primary care coverage plan under Chapter 1579;

11	Sec. 1204.303. PAYMENT IN LIEU OF CLAIM FOR BENEFITS; OTHER
12	DIRECT PAYMENTS. (a) A physician or health care provider may not
13	be prohibited from accepting directly from an enrollee full payment
14	for a health care service in lieu of submitting a claim to the
15	enrollee's health benefit plan.
16	(b) Notwithstanding Section 552.003 or any other law, the
17	charge for a health care service for which a physician or health
18	care provider accepts a payment as described by Subsection (a) or
19	from a patient without a health benefit plan may not exceed the
20	lowest contract rate for the health care service allowable under
21	any health benefit plan with respect to which the physician or
22	health care provider is a contracted, preferred, or participating
23	provider.
24	SECTION 2. This Act takes effect September 1, 2023.
