## H.B. No. 697

1 SECTION 2. Section 5.008(b), Property Code, as amended by this Act, applies only to a transfer of property that occurs on or 2 after the effective date of this Act. A transfer of property that 3 4 occurs before the effective date of this Act is governed by the law applicable to the transfer immediately before that date, and the 5 6 former law is continued in effect for that purpose. For the purposes of this section, a transfer of property occurs before the 7 8 effective date of this Act if the contract binding the purchaser to purchase the property is executed before that date. 9

SECTION 3. This Act takes effect September 1, 2023.
