- 6 SECTION 1. The heading to Article 17.50, Code of Criminal
- 7 Procedure, is amended to read as follows:
- 8 Art. 17.50. ENTRY INTO TEXAS CRIME INFORMATION CENTER OF
- 9 CERTAIN INFORMATION IN CASES INVOLVING VIOLENT OFFENSES OR
- 10 STALKING; DUTIES OF MAGISTRATES, SHERIFFS, AND DEPARTMENT OF PUBLIC
- 11 SAFETY.
- 12 SECTION 2. Articles 17.50(b) and (f), Code of Criminal
- 13 Procedure, are amended to read as follows:
- 14 (b) As soon as practicable but not later than the next day
- 15 after the date a magistrate issues an order imposing a condition of
- 16 bond on a defendant under this chapter for a violent offense or an
- 17 offense under Section 42.072, Penal Code, the magistrate shall
- 18 notify the sheriff of the condition and provide to the sheriff the
- 19 following information:
- 20 (1) the information listed in Section 411.042(b)(6),
- 21 Government Code, as that information relates to an order described
- 22 by this subsection;
- 23 (2) the name and address of any named person the
- 24 condition of bond is intended to protect, and if different and

- 1 applicable, the name and address of the victim of the alleged
- 2 offense;
- 3 (3) the date the order releasing the defendant on bond
- 4 was issued; and
- 5 (4) the court that issued the order releasing the
- 6 defendant on bond.
- 7 (f) The Department of Public Safety shall:
- 8 (1) modify the database to enable the database to
- 9 accept and maintain detailed information on active conditions of
- 10 bond regarding the requirements and status of a condition of bond
- 11 imposed by a magistrate for a violent offense or an offense under
- 12 Section 42.072, Penal Code, including information described by
- 13 Subsections (b) and (c); and
- 14 (2) develop and adopt a form for use by magistrates and
- 15 sheriffs to facilitate the data collection and data entry required
- 16 by this article.
- 17 SECTION 3. Article 17.50, Code of Criminal Procedure, as
- 18 amended by this Act, applies only to condition of bond imposed on or
- 19 after the effective date of this Act. A condition of bond imposed
- 20 before the effective date of this Act is governed by the law in
- 21 effect on the date the condition was imposed, and the former law is
- 22 continued in effect for that purpose.
- 23 SECTION 4. This Act takes effect September 1, 2023.
