Section 38.04, Penal Code, is amended by adding Subsection (b-1) to read as follows: 20 21 (b-1) Notwithstanding Subsection (b), an offense under this section is a felony of the third degree if it is shown on the trial 22 23 of the offense that the actor committed the offense in the course of 24 committing an offense under Section 20.05(a)(2). SECTION 11. The changes in law made by this Act apply only 25 to an offense committed on or after the effective date of this Act. 26

An offense committed before the effective date of this Act is

1 governed by the law in effect on the date the offense was committed,
2 and the former law is continued in effect for that purpose. For
3 purposes of this section, an offense was committed before the
4 effective date of this Act if any element of the offense was
5 committed before that date.

6 SECTION 12. This Act takes effect September 1, 2023.
