1	AN ACT
2	relating to a law enforcement agency accreditation grant program.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Subchapter A, Chapter 772, Government Code, is
5	amended by adding Section 772.0079 to read as follows:
6	Sec. 772.0079. LAW ENFORCEMENT AGENCY ACCREDITATION GRANT
7	PROGRAM. (a) In this section, "criminal justice division" means
8	the criminal justice division established under Section 772.006.
9	(b) This section applies only to a law enforcement agency
10	employing one or more peace officers described by Article 2.12(1),
11	(2), (3), (4), or (8), Code of Criminal Procedure.
12	(c) The criminal justice division shall establish and
13	administer a grant program to provide to each law enforcement
14	agency to which this section applies financial assistance for
15	purposes of becoming accredited or maintaining accreditation:
16	(1) through the Texas Police Chiefs Association Law
17	Enforcement Agency Best Practices Accreditation Program;
18	(2) by the Commission on Accreditation for Law
19	Enforcement Agencies, Inc.;
20	(3) by the International Association of Campus Law
21	Enforcement Administrators; or
22	(4) by an association or organization designated by
23	the criminal justice division under Subsection (h).
24	(d) The amount of a grant awarded under this section may not

1	exceed \$50,000.
2	(e) The criminal justice division shall establish:
3	(1) eligibility criteria for grant applicants;
4	(2) grant application procedures;
5	(3) guidelines relating to grant amounts;
6	(4) procedures for evaluating grant applications;
7	(5) procedures for monitoring the use of a grant
8	awarded under the program and ensuring compliance with any
9	conditions of a grant; and
10	(6) procedures for revoking a grant awarded under the
11	<pre>program if the law enforcement agency:</pre>
12	(A) is not accredited within the period specified
13	by the rules adopted under Subsection (i); or
14	(B) does not renew or otherwise maintain the
15	agency's accreditation.
16	(f) Not later than December 1 of each year, the criminal
17	justice division shall submit to the Legislative Budget Board a
18	report that provides the following information for the preceding
19	<pre>state fiscal year:</pre>
20	(1) the name of each law enforcement agency that
21	applied for a grant under this section; and
22	(2) the amount of money distributed to each law
23	enforcement agency that received a grant under this section.
24	(g) The criminal justice division may use any revenue
25	available for purposes of this section.
26	(h) The criminal justice division, with the assistance of
27	the Texas Commission on Law Enforcement, shall periodically review

- 1 associations and organizations that establish standards of
- 2 practice for law enforcement agencies and that offer accreditation
- 3 to agencies that meet those standards. On a determination by the
- 4 criminal justice division that accreditation of law enforcement
- 5 agencies in this state by an association or organization would
- 6 benefit public safety, the commission may designate the association
- 7 or organization as an accrediting agency for purposes of Subsection
- 8 (c)(4).
- 9 (i) The criminal justice division shall adopt rules
- 10 requiring each law enforcement agency to which this section applies
- 11 to become accredited as described by Subsection (c). The rules must
- 12 require law enforcement agencies to become accredited as follows:
- (1) not later than September 1, 2026, for law
- 14 enforcement agencies employing 50 or more peace officers; and
- 15 (2) not later than September 1, 2027, for law
- 16 <u>enforcement agencies employing fewer than 50 peace officers.</u>
- 17 (j) The criminal justice division shall implement a program
- 18 to assist eligible applicants in becoming accredited as required by
- 19 the rules adopted under Subsection (i).
- 20 (k) A law enforcement agency that receives a grant awarded
- 21 under the program annually shall report the agency's accreditation
- 22 status, including the applicable accrediting agency described by
- 23 Subsection (c)(1), (2), (3), or (4), to the Texas Commission on Law
- 24 Enforcement.
- 25 (1) The Texas Commission on Law Enforcement shall post on
- 26 the commission's Internet website a list of all law enforcement
- 27 agencies that are currently accredited as described by Subsection
