(1) under Section 54.052(a)(3), Education Code, as
that section existed before amendment by this Act, if the student is
not otherwise eligible to be classified as a resident of this state
under Subchapter B, Chapter 54, Education Code; or

9 (2) before the enactment of Section 54.052(c), 10 Education Code, as added by this Act, if the student is not 11 authorized under federal statute to be present in the United 12 States.
