A BILL TO BE ENTITLED

AN ACT

2 relating to the prescribing and ordering of Schedule II controlled 3 substances by certain advanced practice registered nurses and 4 physician assistants.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 6 SECTION 1. Section 157.0511(b-1), Occupations Code, is 7 amended to read as follows:

8 (b-1) A physician may delegate the prescribing or ordering 9 of a controlled substance listed in Schedule II as established by 10 the commissioner of the Department of State Health Services under 11 Chapter 481, Health and Safety Code, only:

12 (1) in a hospital facility-based practice under 13 Section 157.054, in accordance with policies approved by the 14 hospital's medical staff or a committee of the hospital's medical 15 staff as provided by the hospital bylaws to ensure patient safety, 16 and as part of the care provided to a patient who:

17 (A) has been admitted to the hospital for an18 intended length of stay of 24 hours or greater; or

(B) is receiving services in the emergency
department of the hospital; [or]

(2) as part of the plan of care for the treatment of a person who has executed a written certification of a terminal illness, has elected to receive hospice care, and is receiving hospice treatment from a qualified hospice provider; or

1	(3) as part of a narcotic drug treatment program that
2	has been issued a permit under Chapter 466, Health and Safety Code.
3	SECTION 2. Subchapter A, Chapter 562, Occupations Code, is
4	amended by adding Section 562.017 to read as follows:
5	Sec. 562.017. CERTAIN PRESCRIPTIONS FOR CONTROLLED
6	SUBSTANCES. A pharmacist practicing in a Class A pharmacy may
7	dispense a controlled substance listed in Schedule II as
8	established by the commissioner of state health services under
9	Chapter 481, Health and Safety Code, that is prescribed by an
10	advanced practice registered nurse or physician assistant to whom a
11	physician has delegated prescribing and ordering authority under
12	Section 157.0511(b-1). The prescriber shall clearly note in the
13	prescription records that the controlled substance listed in
14	Schedule II is prescribed as part of the care provided:
15	(1) in a hospital facility-based practice described by
16	Section 157.0511(b-1)(1);
17	(2) as part of a plan of care described by Section
18	<u>157.0511(b-1)(2); or</u>
19	(3) as part of a narcotic drug treatment program
20	<pre>described by Section 157.0511(b-1)(3).</pre>
21	SECTION 3. This Act takes effect immediately if it receives
22	a vote of two-thirds of all the members elected to each house, as
23	provided by Section 39, Article III, Texas Constitution. If this
24	Act does not receive the vote necessary for immediate effect, this
25	Act takes effect September 1, 2023.
