2	(6) the plans for the child of any person seeking
3	conservatorship or possession of or access to the child;
4	(7) the stability of any proposed placement;
5	(8) any act or omission by a parent seeking

7	indicate the parent does not act in the best interest of the child;
8	(9) any explanation for the parent's act or omission
9	described by Subdivision (8); and
10	(10) any other factor the court considers relevant to
11	the determination.
12	SECTION 2. The change in law made by this Act applies to a
13	suit affecting the parent-child relationship that is pending in a
14	trial court on the effective date of this Act or filed on or after
15	that date. A suit affecting the parent-child relationship in which
16	a final order is rendered before the effective date of this Act is
17	governed by the law in effect on the date the order was rendered,
18	and the former law is continued in effect for that purpose.

19 SECTION 3. This Act takes effect September 1, 2023.
