1	AN ACT
2	relating to the authority of a physician to provide and dispense and
3	to delegate authority to provide and dispense certain drugs.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 151.002, Occupations Code, is amended by
6	adding Subdivisions (3-a) and (13-a) to read as follows:
7	(3-a) "Dispense" has the meaning assigned by Section
8	<u>551.003.</u>
9	(13-a) "Provision" means the supply of one or more
10	unit doses of a drug, medicine, or dangerous drug.
11	SECTION 2. The heading to Section 157.002, Occupations
12	Code, is amended to read as follows:

- 13 Sec. 157.002. GENERAL DELEGATION OF ADMINISTRATION, [AND]
- 14 PROVISION, AND DISPENSING OF DANGEROUS DRUGS.
- 15 SECTION 3. Sections 157.002(a), (b), (e), and (g),
- 16 Occupations Code, are amended to read as follows:
- 17 (a) In this section, "administering" [÷
- 18 [(1) "Administering"] means the direct application of
- 19 a drug to the body of a patient by injection, inhalation, ingestion,
- 20 or any other means.
- 21 [(2) "Provision" means the supply of one or more unit
- 22 doses of a drug, medicine, or dangerous drug.
- (b) A physician may delegate to any qualified and properly
- 24 trained person acting under the physician's supervision the act of

- 1 administering [or providing] dangerous drugs in the physician's
- 2 office, as ordered by the physician, that are used or required to
- 3 meet the immediate needs of the physician's patients or the act of
- 4 providing or dispensing dangerous drugs as ordered by the physician
- 5 to the physician's patients. The administration, [or] provision,
- 6 or dispensing of the dangerous drugs must be performed in
- 7 compliance with laws relating to the practice of medicine and state
- 8 and federal laws relating to those dangerous drugs.
- 9 (e) The administration, [or dispensing of
- 10 the drugs may be delegated through a physician's order, a standing
- 11 medical order, a standing delegation order, or another order
- 12 defined by the board.
- 13 (g) A drug or medicine provided or dispensed under
- 14 Subsection (b) or (c) must be supplied in a suitable container
- 15 labeled in compliance with applicable drug laws. A qualified and
- 16 trained person, acting under the supervision of a physician, may
- 17 specify at the time of the provision or dispensing of the drug the
- 18 inclusion on the container of the date of the provision or
- 19 dispensing and the patient's name and address.
- SECTION 4. The heading to Chapter 158, Occupations Code, is
- 21 amended to read as follows:
- 22 CHAPTER 158. AUTHORITY OF PHYSICIAN TO PROVIDE OR DISPENSE CERTAIN
- DRUGS AND SUPPLIES
- SECTION 5. Sections 158.001(a) and (c), Occupations Code,
- 25 are amended to read as follows:
- 26 (a) A physician licensed under this subtitle may provide
- 27 [supply] a patient with any drug, remedy, or clinical supply

- 1 necessary to meet the patient's immediate needs.
- 2 (c) This chapter does not prohibit a physician from
- 3 providing [supplying] to a patient, free of charge, a drug provided
- 4 to the physician by a drug manufacturer for an indigent
- 5 pharmaceutical program if, in the physician's opinion, it is
- 6 advantageous to the patient, in adhering to a course of treatment
- 7 prescribed by the physician, to receive the drug.
- 8 SECTION 6. Section 158.002(a), Occupations Code, is amended
- 9 to read as follows:
- 10 (a) This chapter does not prohibit a physician from
- 11 providing [supplying] a pharmaceutical sample to a patient free of
- 12 charge if, in the physician's opinion, it is advantageous to the
- 13 patient, in adhering to a course of treatment prescribed by the
- 14 physician, to receive the sample.
- 15 SECTION 7. The heading to Section 158.003, Occupations
- 16 Code, is amended to read as follows:
- 17 Sec. 158.003. DISPENSING OF DANGEROUS DRUGS TO CERTAIN
- 18 PATIENTS IN CERTAIN RURAL AREAS.
- 19 SECTION 8. Section 158.003, Occupations Code, is amended by
- 20 adding Subsection (a-1) to read as follows:
- 21 <u>(a-1)</u> This section applies only to a physician providing
- 22 care under workers' compensation insurance coverage, as defined by
- 23 Section 401.011, Labor Code.
- SECTION 9. Chapter 158, Occupations Code, is amended by
- 25 adding Section 158.004 to read as follows:
- 26 Sec. 158.004. PROVISION AND DISPENSING OF DANGEROUS DRUGS.
- 27 (a) In this section, "reimbursement for cost" means an additional

- 1 charge, separate from that imposed for the physician's professional
- 2 services, that includes the cost of a drug product and all other
- 3 actual costs to the physician incidental to providing dispensing
- 4 service. The term does not include a separate fee imposed for the
- 5 act of dispensing a drug itself.
- 6 (b) This section does not apply to a physician providing
- 7 <u>care under workers' compensation insurance coverage, as defined by</u>
- 8 Section 401.011, Labor Code.
- 9 (c) A physician may:
- 10 (1) provide or dispense dangerous drugs to the
- 11 physician's patients; and
- 12 (2) be reimbursed for the cost of providing or
- 13 dispensing those drugs without obtaining a license under Chapter
- 14 558.
- 15 (d) A physician may not provide or dispense under this
- 16 <u>section a controlled substance listed in Schedules II through V as</u>
- 17 <u>established under Subchapter B, Chapter 481, Health and Safety</u>
- 18 Code.
- 19 (e) A physician who provides or dispenses dangerous drugs
- 20 under this section shall oversee compliance with the laws of this
- 21 state and federal law relating to those dangerous drugs.
- 22 (f) Before providing or dispensing dangerous drugs under
- 23 this section, a physician must notify the patient that the
- 24 prescription for the dangerous drug may be filled at a pharmacy.
- 25 With respect to dangerous drugs provided or dispensed in a
- 26 physician's office, the notification requirement of this
- 27 subsection may be satisfied by a written notice placed

- 1 conspicuously in the office.
- 2 (g) Not later than the 30th day after the date a physician
- 3 first provides or dispenses dangerous drugs under this section, the
- 4 physician shall notify the Texas State Board of Pharmacy and the
- 5 board that the physician is providing or dispensing dangerous drugs
- 6 under this section. The Texas State Board of Pharmacy and the board
- 7 shall jointly adopt a form by which a physician may provide
- 8 notification as required by this subsection.
- 9 (h) A physician who notifies the board under Subsection (g)
- 10 that the physician is providing or dispensing dangerous drugs under
- 11 this section and who intends to continue to provide or dispense
- 12 dangerous drugs under this section shall include notice of that
- 13 intent in any subsequent registration permit renewal application
- 14 submitted to the board. The board by rule shall prescribe the form
- 15 of a registration permit renewal application in accordance with
- 16 this subsection.
- SECTION 10. Section 551.003(31), Occupations Code, is
- 18 amended to read as follows:
- 19 (31) "Pharmacy" means a facility at which a
- 20 prescription drug or medication order is received, processed, or
- 21 dispensed under this subtitle, Chapter 481 or 483, Health and
- 22 Safety Code, or the Comprehensive Drug Abuse Prevention and Control
- 23 Act of 1970 (21 U.S.C. Section 801 et seq.). The term does not
- 24 include:
- 25 (A) a narcotic drug treatment program that is
- 26 regulated under Chapter 466, Health and Safety Code; or
- 27 (B) a location where:

- 1 (i) a physician provides or dispenses a
- 2 dangerous drug under Section 158.003 or 158.004; or
- 3 <u>(ii) a person provides or dispenses a</u>
- 4 dangerous drug under a physician's supervision in accordance with
- 5 Section 157.002(b).
- 6 SECTION 11. Section 551.004, Occupations Code, is amended
- 7 by adding Subsection (a-1) and amending Subsection (b) to read as
- 8 follows:
- 9 (a-1) For purposes of Subsection (a)(1), "retailing of
- 10 prescription drugs" does not include the collection of a
- 11 reimbursement for cost, as defined by Section 158.003(a) or
- 12 158.004(a).
- 13 (b) This subtitle does not prevent:
- 14 (1) a practitioner from:
- 15 <u>(A)</u> administering a drug to a patient of the
- 16 practitioner; or
- 17 (B) providing or dispensing dangerous drugs
- 18 under Section 158.003 or 158.004; or
- 19 (2) a person from providing or dispensing a dangerous
- 20 drug under a physician's supervision in accordance with Section
- 21 <u>157.002(b)</u>.
- 22 SECTION 12. Section 558.001, Occupations Code, is amended
- 23 by amending Subsection (c) and adding Subsection (d) to read as
- 24 follows:
- (c) Except as provided by Subsection (d), a [A] person may
- 26 not dispense or distribute prescription drugs unless the person:
- 27 (1) is a pharmacist; or

- 1 (2) is otherwise authorized by this subtitle to
- 2 dispense or distribute prescription drugs.
- 3 (d) A physician or person acting under the physician's
- 4 supervision may provide or dispense dangerous drugs in accordance
- 5 with Section 157.002(b), 158.003, or 158.004.
- 6 SECTION 13. The heading to Chapter 563, Occupations Code,
- 7 is amended to read as follows:
- 8 CHAPTER 563. [PRESCRIPTION REQUIREMENTS;] DELEGATION OF
- 9 ADMINISTRATION, [AND] PROVISION, AND DISPENSING OF DANGEROUS DRUGS
- SECTION 14. Sections 563.051(a) and (c), Occupations Code,
- 11 are amended to read as follows:
- 12 (a) A physician may delegate to any qualified and properly
- 13 trained person acting under the physician's supervision the act of
- 14 administering [or providing] dangerous drugs in the physician's
- 15 office, as ordered by the physician, that are used or required to
- 16 meet the immediate needs of the physician's patients or the act of
- 17 providing or dispensing dangerous drugs, as ordered by the
- 18 physician, to the physician's patients. The administration, [or]
- 19 provision, or dispensing of the dangerous drugs must be performed
- 20 in compliance with laws relating to the practice of medicine and
- 21 state and federal laws relating to those dangerous drugs.
- (c) The administration, [or provision, or dispensing of
- 23 the drugs may be delegated through a physician's order, a standing
- 24 medical order, a standing delegation order, or another order
- 25 defined by the Texas Medical [State] Board [of Medical Examiners].
- SECTION 15. Section 563.052, Occupations Code, is amended
- 27 to read as follows:

- 1 Sec. 563.052. SUITABLE CONTAINER REQUIRED. A drug or
- 2 medicine provided or dispensed under this subchapter must be
- 3 provided or dispensed [supplied] in a suitable container labeled in
- 4 compliance with applicable drug laws. A qualified and trained
- 5 person, acting under the supervision of a physician, may specify at
- 6 the time of the provision or dispensing of the drug the inclusion on
- 7 the container of the date of the provision or dispensing and the
- 8 patient's name and address.
- 9 SECTION 16. The heading to Section 563.053, Occupations
- 10 Code, is amended to read as follows:
- 11 Sec. 563.053. DISPENSING OF DANGEROUS DRUGS TO CERTAIN
- 12 PATIENTS IN CERTAIN RURAL AREAS.
- 13 SECTION 17. Section 563.053, Occupations Code, is amended
- 14 by adding Subsection (a-1) to read as follows:
- 15 <u>(a-1)</u> This section applies only to a physician providing
- 16 care under workers' compensation insurance coverage, as defined by
- 17 Section 401.011, Labor Code.
- 18 SECTION 18. The heading to Subchapter B, Chapter 563,
- 19 Occupations Code, is repealed.
- 20 SECTION 19. This Act takes effect September 1, 2023.
