documentation that describes the sexual assault of the individual 1 or a member of the individual's immediate family or family violence 2 3 against the individual that: 4 (i) is recorded in any form or medium that 5 identifies the individual or member of the individual's immediate family, as applicable, as the patient; and 6 7 (ii) relates to the history, diagnosis, treatment, or prognosis of the patient; or 8 9 (D) written documentation from a family violence center or rape crisis center that describes the sexual assault of 10 the individual or a member of the individual's immediate family or 11 12 family violence against the individual; (3) the individual leaves the workplace to care for 13 14 the individual's terminally ill spouse as evidenced by a 15 physician's statement or other medical documentation, but only if no reasonable, alternative care was available; [or] 16 17 (4) the individual's separation from employment was caused by the individual being called to provide: 18 19 (A) service in the uniformed services, as defined by 38 U.S.C. Section 4303; or 20 21 (B) service in the Texas military forces, as defined by Section 437.001, Government Code; or 22 (5) the individual leaves the workplace to care for 23 24 the individual's minor child due to an unexpected illness, accident, or other unforeseeable event, but only if no reasonable, 25 26 alternative care was available. SECTION 2. The change in law made by this Act applies only 27

1 to a claim for unemployment compensation benefits filed with the 2 Texas Workforce Commission on or after the effective date of this 3 Act. A claim filed before the effective date of this Act is 4 governed by the law in effect on the date the claim was filed, and 5 the former law is continued in effect for that purpose.

6 SECTION 3. This Act takes effect September 1, 2023.
