A BILL TO BE ENTITLED

AN ACT

2 relating to the establishment by certain counties and hospital 3 districts of disease control pilot programs to reduce the risk of 4 certain infectious and communicable diseases; authorizing fees.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. This Act shall be cited as the Honorable Ruth 7 Jones McClendon Act.

SECTION 2. The legislature finds that because drug abuse 8 9 has been a tragedy for many Texas families, providing individuals who are addicted to drugs with education about and treatment for 10 11 addiction is imperative. Cooperation with community-based and faith-based organizations creates a network of support for Texas 12 families and the opportunity to intervene in drug addiction. 13 14 Members of community-based and faith-based organizations have a strong desire to compassionately preserve lives and help those 15 16 stricken with disease and drug addiction.

Allowing the operation of disease control pilot programs will 17 18 reduce the transmission of blood-borne diseases, including HIV/AIDS, hepatitis B, and hepatitis C, and provide program 19 participants with referrals to appropriate health and social 20 21 services. A pilot program established under this Act may provide necessary access to primary health care, ensure safe and sterile 22 23 disposal of used syringes and needles, and protect the public 24 health. Pilot program goals may include reduced rates of

1 intravenous drug use and a reduced number of injuries to innocent 2 victims, first responders, and law enforcement caused by needle 3 sticks from improperly disposed needles. Additionally, it is the 4 intent of the legislature for a pilot program to increase access to 5 substance abuse treatment services, increase the likelihood of 6 successful treatments for addiction, and protect the public health 7 and safety.

8 SECTION 3. Section 531.0972, Government Code, is amended to 9 read as follows:

Sec. 531.0972. PILOT PROGRAM TO PREVENT [THE] SPREAD OF 10 CERTAIN INFECTIOUS \underline{AND} [\underline{OR}] COMMUNICABLE DISEASES. The commission 11 12 may provide guidance to the counties and hospital districts in those counties that establish [local health authority of Bexar 13 14 County in establishing] a disease control pilot program under Subchapter K, Chapter 81, Health and Safety Code, [funded by the 15 county] to prevent the spread of HIV, hepatitis B, hepatitis C, and 16 17 other infectious and communicable diseases. Each [The] program may include a disease control outreach strategy [program] that provides 18 19 for the anonymous exchange of used hypodermic needles and syringes. 20 SECTION 4. Chapter 81, Health and Safety Code, is amended by

21 adding Subchapter K to read as follows:

<u>SUBCHAPTER K. PILOT PROGRAMS TO REDUCE RISK OF CERTAIN INFECTIOUS</u> <u>AND COMMUNICABLE DISEASES</u> <u>Sec. 81.501. APPLICABILITY OF SUBCHAPTER. This subchapter</u> <u>applies only to Bexar, Dallas, El Paso, Harris, Nueces, Travis, and</u>

26 Webb Counties and hospital districts in those counties.

27 Sec. 81.502. DISEASE CONTROL PILOT PROGRAM. (a) A county

No. 1403 1 or hospital district may establish a disease control pilot program under this subchapter to prevent the spread of infectious and 2 communicable diseases, including HIV, hepatitis B, and hepatitis C. 3 The pilot program may include disease control outreach strategies 4 5 to: 6 (1) provide for the anonymous exchange of used hypodermic needles and syringes for an equal number of new 7 8 hypodermic needles and syringes; 9 (2) offer education on the transmission and prevention of infectious and communicable diseases, including HIV, hepatitis 10 B, and hepatitis C; and 11 12 (3) assist program participants in obtaining health care and other physical and mental health-related services, 13 including substance abuse treatment services and blood-borne 14 15 disease testing. (b) A county or hospital district may register an 16 17 organization to operate the disease control pilot program and distribute hypodermic needles and syringes to control the spread of 18 19 certain infectious and blood-borne communicable diseases. The county or hospital district may charge the organization a 20 registration fee in an amount reasonable and necessary to cover the 21 costs of registration oversight, including coordination with law 22 23 enforcement personnel. 24 (c) A registered organization may charge a program participant a fee for each hypodermic needle or syringe used in the 25 26 program not to exceed 150 percent of the actual cost to the

27 organization of the hypodermic needle or syringe.

No. 1403 1 (d) A registered organization shall annually provide to the 2 department and the county or hospital district that registered the 3 organization information on: 4 (1) the effectiveness of the disease control pilot 5 program; 6 (2) the program's impact on reducing the spread of 7 infectious and communicable diseases, including HIV, hepatitis B, 8 and hepatitis C; and 9 (3) the program's effect on injected drug use by 10 individuals residing within the county or hospital district. Sec. 81.503. DISTRIBUTION OF NEEDLES AND SYRINGES TO PILOT 11 12 PROGRAM. A person licensed as a wholesale drug distributor or device distributor under Chapter 431 may distribute hypodermic 13 needles and syringes to a disease control pilot program authorized 14 15 by this subchapter. Sec. 81.504. HANDLING OF NEEDLES AND SYRINGES. 16 An 17 organization registered as provided by Section 81.502: (1) shall store hypodermic needles and syringes in a 18 19 proper and secure manner and allow only authorized employees or volunteers of the organization's disease control pilot program to 20 access the hypodermic needles and syringes; 21 (2) may include hypodermic needles and syringes in 22 packaged safe kits made available to program participants through 23 24 the program; 25 (3) may provide hypodermic needles and syringes and 26 safe kits to program participants only through an authorized 27 employee or volunteer of the program; and

(4) shall store and dispose of used hypodermic needles 1 and syringes in accordance with applicable state laws and 2 administrative rules governing the safe and proper disposal of 3 medical waste. 4 5 Sec. 81.505. FUNDING. Except to the extent specifically prohibited by law, an organization registered to operate a disease 6 7 control pilot program as provided by Section 81.502 may solicit or 8 accept gifts, grants, or donations to fund the program. 9 Sec. 81.506. EXPIRATION. This subchapter expires September 10 1, 2033. SECTION 5. Section 481.125, Health and Safety Code, is 11 12 amended by adding Subsections (j), (k), (l), and (m) to read as follows: 13 14 (j) Subsections (a) and (b) do not apply to a person who 15 possesses or delivers a hypodermic needle or syringe for a medical purpose. For the purposes of this subsection, "medical purpose" 16 17 includes the exchange of a hypodermic needle or syringe for a used hypodermic needle or syringe in a disease control pilot program 18 19 described by Subchapter K, Chapter 81. (k) Subsections (a) and (b) do not apply to a person who 20 possesses or manufactures hypodermic needles or syringes for 21 delivery to a disease control pilot program described by Subchapter 22 23 K, Chapter 81. 24 (1) Subsections (a) and (b) do not apply to a person who is an employee, volunteer, duly authorized agent, or program 25 26 participant of a disease control pilot program described by Subchapter K, Chapter 81, and uses, possesses, or delivers a 27

1 hypodermic needle or syringe as part of the program.

2 (m) This subsection and Subsections (j), (k), and (l) expire
3 September 1, 2033.

4 SECTION 6. The change to Section 481.125, Health and Safety Code, made by this Act applies only to an offense committed on or 5 6 after the effective date of this Act. An offense committed before the effective date of this Act is governed by the law in effect when 7 the offense was committed, and the former law is continued in effect 8 for that purpose. For purposes of this section, an offense is 9 committed before the effective date of this Act if any element of 10 the offense occurs before the effective date. 11

12 SECTION 7. This Act takes effect September 1, 2023.
