A BILL TO BE ENTITLED

AN ACT

2 relating to the authority of certain counties to impose a hotel 3 occupancy tax.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 352.002(a), Tax Code, is amended to read 6 as follows:

7 (a) The commissioners courts of the following counties by 8 the adoption of an order or resolution may impose a tax on a person 9 who, under a lease, concession, permit, right of access, license, 10 contract, or agreement, pays for the use or possession or for the 11 right to the use or possession of a room that is in a hotel, costs \$2 12 or more each day, and is ordinarily used for sleeping:

13 (1) a county that has a population of more than 3.3 14 million;

15 (2) a county that has a population of 90,000 or more, 16 borders the United Mexican States, does not border the Gulf of 17 Mexico, and does not have four or more cities that each have a 18 population of more than 25,000;

(3) a county in which there is no municipality;

(4) a county in which there is located an Indian
reservation under the jurisdiction of the United States government;
(5) a county that has a population of 30,000 or less,
that has no more than one municipality with a population of less
than 2,500, and that borders two counties located wholly in the

No. 1410 incorporated municipalities, each with a population of 800 or less, 1 at least one of which is located on the Frio River; 2 3 (17)a county that has a population of 34,000 or more and borders Lake Buchanan; 4 5 a county that has a population of more than 45,000 (18)and less than 75,000, that borders the United Mexican States, and 6 that borders or contains a portion of Falcon Lake; 7 8 (19)a county with a population of 22,000 or less that borders the Neches River and in which there is located a national 9 10 preserve; 11 (20) a county that has a population of 28,000 or less 12 and that borders or contains a portion of Lake Livingston; a county through which the Pedernales River flows 13 (21)and in which the birthplace of a president of the United States is 14 15 located; (22) a county that has a population of more than 15,000 16 but less than 20,000 and borders Lake Buchanan; 17 a county with a population of less than 11,000 18 (23) 19 that is bordered by the Sulphur River; 20 (24) a county that has a population of 16,000 or more and borders the entire north shore of Lake Somerville; 21 a county that has a population of 20,000 or less 22 (25) and that is bordered by the Brazos and Navasota Rivers; 23 24 a county that has a population of more than 15,000 (26) and less than 25,000 and is located on the Trinity and Navasota 25 26 Rivers; 27 (27) a county that has a population of less than 15,000

1 and that is bordered by the Trinity and Navasota Rivers;

2 (28) a county that borders or contains a portion of the
3 Neches River, the Sabine River, and Sabine Lake; and

4 (29) a county that borders Whitney Lake.

5 SECTION 2. This Act takes effect immediately if it receives 6 a vote of two-thirds of all the members elected to each house, as 7 provided by Section 39, Article III, Texas Constitution. If this 8 Act does not receive the vote necessary for immediate effect, this 9 Act takes effect September 1, 2023.
