## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the disposition of real property interests by navigation districts and port authorities. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. The heading to Section 60.038, Water Code, is amended to read as follows: 6 Sec. 60.038. <u>DISPOSITION</u> [SALE OR LEASE] OF <u>INTERESTS IN</u> 7 REAL PROPERTY [LAND]. 8 SECTION 2. Section 60.038, Water Code, is amended by 9 amending Subsections (a), (b), and (c) and adding Subsections (e), 10 11 (f), (g), and (h) to read as follows: 12 (a) A district may sell, exchange, or lease real property or any interest in real property [all or any part of land] owned by it, 13 14 whether the real property was [land is] acquired by gift or purchase, in settlement of any litigation, controversy, or claim in 15 16 behalf of the district, or in any other manner, except that lands or flats heretofore purchased from the State of Texas under former 17 Article 8225, Revised Civil Statutes of Texas, 1925, or granted by 18 the State of Texas in any general or special act, may be sold only to 19

21 lands or exchanged for adjacent littoral land as authorized by 22 Section 61.117 [of this code]. <u>The district may impose</u> 23 restrictions on the development, use, and transfer of any real 24 property or interest in real property in connection with its sale or

2 (b) Except as provided by Subsection (e), before [Before] a 3 district may sell or exchange real property [land], the commission 4 shall determine by resolution that the <u>real property</u> [land] is no 5 longer needed for use by the district in connection with the 6 development of a navigation project.

7 (c) <u>Except as provided by Subsection (e), (f), or (g), a</u> 8 <u>sale</u> [<del>Sale</del>] or <u>exchange</u> [<del>lease</del>] of <u>real property</u> [<del>land</del>] shall be 9 made as provided by Sections <u>60.040</u>, <u>60.041</u>, <u>and 60.042</u> 10 [<del>60.039-60.042 of this code</del>].

(e) A district may donate, exchange, convey, sell, or lease 11 12 land, improvements, easements, or any other interests in real property to an electric utility, as that term is defined by Section 13 31.002, Utilities Code, or a telecommunications utility, as that 14 15 term is defined by Section 51.002, Utilities Code, to promote a public purpose related to the development of the district. The 16 17 district shall determine the terms and conditions of the transaction so as to: 18

(1) achieve the public purpose; and

20 (2) be consistent with the requirements of Title 2, 21 <u>Utilities Code.</u>

22 (f) A district may donate, exchange, convey, sell, or lease 23 a real property interest under Subsection (e) for less than its fair 24 market value and without complying with the notice and bidding 25 requirements of Sections 60.040, 60.041, and 60.042.

26 (g) Narrow strips of real property resulting from boundary 27 or surveying conflicts or similar causes, or from insubstantial

1 encroachments by abutting real property owners, or real property of larger configuration that has been subject to encroachments by 2 abutting real property owners for more than 25 years may be 3 abandoned, released, exchanged, or transferred to such abutting 4 5 owners on terms and conditions considered appropriate or advantageous to the district. A district may convey real property 6 under this subsection for less than its fair market value and 7 without complying with the notice and bidding requirements of 8 Sections 60.040, 60.041, and 60.042. 9 (h) The authority granted to a district by this section to 10 dispose of interests in real property is in addition to any 11

11 dispose of interests in real property is in addition to any 12 authority granted by Chapter 272, Local Government Code, and a 13 disposition of an interest in real property under this section is 14 exempt from the notice, bidding, and other requirements of Chapter 15 272, Local Government Code.

16 SECTION 3. This Act takes effect immediately if it receives 17 a vote of two-thirds of all the members elected to each house, as 18 provided by Section 39, Article III, Texas Constitution. If this 19 Act does not receive the vote necessary for immediate effect, this 20 Act takes effect September 1, 2023.
