| 6  | BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:             |
| 7  | SECTION 1. Chapter 2, Code of Criminal Procedure, is                |
| 8  | amended by adding Article 2.36 to read as follows:                  |
| 9  | Art. 2.36. HANDLE WITH CARE NOTICE REGARDING CERTAIN PUBLIC         |
| 10 | SCHOOL STUDENTS. (a) This article applies in any situation in which |
| 11 | a law enforcement agency determines that a public school student    |
| 12 | witnessed or otherwise experienced a traumatic event. For purposes  |
| 13 | of this article, a "traumatic event" includes the following events: |
| 14 | (1) the arrest of an individual who resides with a                  |
| 15 | student;  |
| 16 | (2) the execution of a search warrant at a student's                |
| 17 | residence;  |
| 18 | (3) an overdose of alcohol or of a controlled                       |
| 19 | substance by an individual who resides with a student;              |
| 20 | (4) suicide or attempted suicide committed by an                    |
| 21 | individual who resides with a student;                              |
| 22 | (5) an incident involving family violence, as defined               |
| 23 | by Section 71.004, Family Code;                                     |
| 24 | (6) an incident of assault or sexual assault;                       |

| 1  | (7) a severe motor vehicle accident that causes bodily             |
| 2  | injury or death;   |
| 3  | (8) a mass shooting;   |
| 4  | (9) a student's forced displacement from the student's             |
| 5  | residence;   |
| 6  | (10) an incident involving the Department of Family                |
| 7  | and Protective Services;   |
| 8  | (11) a fire that causes severe property damage or                  |
| 9  | bodily injury or death; or   |
| 10 | (12) any other event that may negatively impact the                |
| 11 | student's ability to succeed in school.                            |
| 12 | (b) A law enforcement agency that determines, in the course        |
| 13 | of providing law enforcement services, that an individual who is   |
| 14 | enrolled as a student in a public primary or secondary school has  |
| 15 | experienced a traumatic event may submit a handle with care notice |
| 16 | to the superintendent or other designated school employee at the   |
| 17 | school at which the student is enrolled.                           |
| 18 | (c) A handle with care notice must include, if known:              |
| 19 | (1) the student's name, age, and grade level;                      |
| 20 | (2) the school at which the student is enrolled; and               |
| 21 | (3) a brief description of the traumatic event                     |
| 22 | experienced by the student.  |
| 23 | (d) A law enforcement agency shall submit handle with care         |
| 24 | notices using an electronic system that:                           |
| 25 | (1) stores the number of notices sent and the zip code             |
| 26 | from which each notice was sent; and                               |
| 27 | (2) automatically sends a copy of the notice to the                |

regional education service center serving the school at which the
 student who is the subject of the notice is enrolled.

3 <u>(e) A superintendent or other designated school employee</u> 4 <u>who receives a handle with care notice shall immediately provide a</u> 5 <u>copy of the handle with care notice to all instructional and support</u> 6 <u>personnel who have responsibility for supervision of the student</u> 7 who is the subject of the notice.

8 (f) Information contained in a handle with care notice 9 authorized under this article is confidential and exempt from 10 disclosure except as provided by this article or other applicable 11 state and federal law. Except as provided by Subsection (e), all 12 school personnel who receive a copy of the handle with care notice 13 shall keep that information confidential.

14 (g) A law enforcement agency must ensure that law 15 enforcement officers and other agency employees receive 16 appropriate training regarding a handle with care notice, including 17 by requiring appropriate agency personnel to attend the training 18 established and maintained under Section 1701.2635, Occupations 19 <u>Code.</u>

20 SECTION 2. Subchapter A, Chapter 38, Education Code, is 21 amended by adding Section 38.035 to read as follows:

Sec. 38.035. HANDLE WITH CARE NOTICE TRAINING COURSE. (a)
The agency shall establish and maintain a one-hour training course
regarding handle with care notices for school district or
open-enrollment charter school employees who have responsibility
for the supervision of students.

authorized under Article 2.36, Code of Criminal Procedure, 2 including appropriate methods of monitoring and responding to a 3 student who is the subject of a handle with care notice. 4 5 (c) Each school district and open-enrollment charter school shall ensure that appropriate personnel complete the training 6 7 course established under this section. 8 SECTION 3. Subchapter F, Chapter 1701, Occupations Code, is amended by adding Section 1701.2635 to read as follows: 9 Sec. 1701.2635. HANDLE WITH CARE NOTICE TRAINING PROGRAM. 10 The commission shall establish and maintain a one-hour training 11 12 program for peace officers and other employees of law enforcement agencies that provides information on the implementation of 13 procedures relating to handle with care notices authorized under 14 Article 2.36, Code of Criminal Procedure. 15 SECTION 4. As soon as practicable after the effective date 16 of this Act: 17 (1)the Texas Education Agency shall develop the 18 19 handle with care notice training course as required by Section
