1-20 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-21 SECTION 1. Section 508.149(a), Government Code, is amended
 1-22 to read as follows:

1-23 (a) An inmate may not be released to mandatory supervision
 1-24 if the inmate is serving a sentence for or has been previously
 1-25 convicted of:

1-26 (1) an offense for which the judgment contains an
 1-27 affirmative finding under Article 42A.054(c) or (d), Code of
 1-28 Criminal Procedure;

1-29 (2) a first degree felony or a second degree felony
 1-30 under Section 19.02, Penal Code;

1-31 (3) a capital felony under Section 19.03, Penal Code;

1-32 (4) a first degree felony or a second degree felony
 1-33 under Section 20.04, Penal Code;

1-34 (5) an offense under Section 21.11, Penal Code;

1-35 (6) a felony under Section 22.011, Penal Code;

1-36 (7) a first degree felony or a second degree felony
 1-37 under Section 22.02, Penal Code;

1-38 (8) a first degree felony under Section 22.021, Penal
 1-39 Code;

1-40 (9) a first degree felony under Section 22.04, Penal
 1-41 Code;

1-42 (10) a first degree felony under Section 28.02, Penal

2-7 SECTION 2. The change in law made by this Act applies only
2-8 to an offense committed on or after the effective date of this Act.
2-9 An offense committed before the effective date of this Act is
2-10 governed by the law in effect on the date the offense was committed,
2-11 and the former law is continued in effect for that purpose.

2-12 SECTION 3. This Act takes effect September 1, 2023.
