1 (3) the offense is committed by intentionally, 2 knowingly, or recklessly impeding the normal breathing or 3 circulation of the blood of the person by applying pressure to the 4 person's throat or neck or by blocking the person's nose or mouth.

SECTION 2. The change in law made by this Act applies only 5 to an offense committed on or after the effective date of this Act. 6 An offense committed before the effective date of this Act is 7 8 governed by the law in effect on the date the offense was committed, and the former law is continued in effect for that purpose. 9 For purposes of this section, an offense was committed before the 10 effective date of this Act if any element of the offense occurred 11 before that date. 12

SECTION 3. This Act takes effect September 1, 2023.
