- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 8 SECTION 1. Section 11.164, Education Code, is amended by
- 9 amending Subsection (a) and adding Subsection (a-1) to read as
- 10 follows:
- 11 (a) The board of trustees of each school district shall
- 12 limit redundant requests for information and the number and length
- 13 of written reports that a classroom teacher is required to prepare.
- 14 A classroom teacher may not be required to prepare any written
- 15 information other than:
- 16 (1) any report concerning the health, safety, or
- 17 welfare of a student;
- 18 (2) a report of a student's grade on an assignment or
- 19 examination;
- 20 (3) a report of a student's academic progress in a
- 21 class or course;
- 22 (4) a report of a student's grades at the end of each
- 23 grade reporting period;
- 24 (5) a report on instructional materials;

- 1 (6) <u>subject to Subsection (a-1)</u>, a unit or weekly
- 2 lesson plan that outlines, in a brief and general manner, the

- 6 (8) any report required for accreditation review;
- 7 (9) any information required by a school district that
- 8 relates to a complaint, grievance, or actual or potential

- 13 <u>(a-1)</u> A unit or weekly lesson plan that is included in

- SECTION 2. Section 21.044(a-1), Education Code, is amended

- 11 Sec. 21.4045. PLANNING AND NONINSTRUCTIONAL DUTIES OF
- 12 TEACHERS. (a) A school district may permit, but may not require, a
- 13 classroom teacher for a foundation curriculum course to spend
- 14 planning and preparation time to which the teacher is entitled
- 15 <u>under Section 21.404 creating or selecting instructional materials</u>
- 16 to cover the applicable essential knowledge and skills for the
- 17 course unless the contract under which the teacher is employed
- 18 explicitly states that the teacher is responsible for duties
- 19 relating to lesson plan design or instructional material selection.
- 20 (b) A contract between a school district and a classroom
- 21 <u>teacher under which a teacher is assigned responsibility for duties</u>
- 22 <u>unrelated to providing instruction and that requires the teacher to</u>
- 23 work a greater number of hours than the number of hours worked by
- 24 other full-time teachers of the same grade level in the district
- 25 must explicitly state each of the teacher's duties unrelated to
- 26 providing instruction.
- 27 SECTION 4. Subchapter B, Chapter 22, Education Code, is

- 1 amended by adding Section 22.05125 to read as follows:
- 2 Sec. 22.05125. IMMUNITY FROM DISCIPLINARY PROCEEDINGS FOR

- 5 (b) A classroom teacher employed by a school district may
- 6 not be subject to disciplinary proceedings for an allegation that

- 10 (1) the teacher used only instructional material
- 11 included on the list of approved instructional material maintained

- Sec. 26.0061. RIGHT TO REQUEST INSTRUCTIONAL MATERIAL
- 21 REVIEW. (a) The board of trustees of each school district shall
- 22 establish a process by which a parent of a student, as indicated on
- 23 the student registration form at the student's campus, may request
- 24 an instructional material review under Section 31.0252 for a
- 25 subject area in the grade level in which the student is enrolled.
- 26 (b) A process established under Subsection (a):
- 27 (1) may not require more than one parent of a student

- 1 to make the request;
- 2 (2) must provide for the board of trustees of the
- 3 school district to determine if the request will be granted, either
- 4 originally or through an appeal process; and
