A BILL TO BE ENTITLED 1 AN ACT 2 relating to a study by the Texas Department of Transportation on 3 future transportation needs for the year 2045. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. DEFINITION. In this Act, "department" means the 5 Texas Department of Transportation. 6 SECTION 2. STUDY. (a) The department, in consultation with 7 the Texas A&M Transportation Institute, shall conduct a study on 8 the state's projected transportation needs and costs and the 9 resulting benefits of meeting those needs and costs for the year 10 11 2045. 12 (b) The study must: 13 (1) use models from the state's metropolitan planning 14 organizations and rural planning efforts to capture regional and local transportation needs; 15 incorporate current, high quality vehicle-based 16 (2) data sources to analyze changing travel patterns and behaviors; 17 18 (3) develop a forecast for alternative levels of mobility and infrastructure performance for: 19 20 (A) highway maintenance; 21 (B) urban mobility; and 22 (C) rural connectivity; 23 (4) develop a range of future state transportation performance and infrastructure condition goals for the period 24

9 (6) evaluate current funding levels and dedicated 10 funding streams, including anticipated funds transferred to the 11 state highway fund under Section 49-g, Article III, Texas 12 Constitution, or deposited to that fund under Section 7-c, Article 13 VIII, Texas Constitution, to quantify the gap between likely 14 funding and the amount required to meet a range of performance 15 conditions;

16 (7) identify strategies and funding options to fill 17 any gaps in transportation needs; and

18 (8) overlay information in the 2030 Committee's 2011 19 report analysis for the period from 2010 to 2035 to compare the 20 funding landscape and performance expectations in 2011 with the 21 current outlook.

SECTION 3. COMMITTEE. The Texas Transportation Commission shall appoint a committee composed of experienced and respected business and community leaders in this state to provide guidance and direction to the department and the Texas A&M Transportation Institute for purposes of conducting the study required by this Act.

1 SECTION 4. REPORT TO LEGISLATURE. Not later than December 2 1, 2024, the Texas Department of Transportation shall submit a 3 report to the legislature that includes the results of the study 4 conducted under this Act and any associated recommendations.

5 SECTION 5. EXPIRATION. This Act expires January 1, 2025.

6 SECTION 6. EFFECTIVE DATE. This Act takes effect 7 immediately if it receives a vote of two-thirds of all the members 8 elected to each house, as provided by Section 39, Article III, Texas 9 Constitution. If this Act does not receive the vote necessary for 10 immediate effect, this Act takes effect September 1, 2023.
