A BILL TO BE ENTITLED

1	AN ACT
2	relating to the issuance of a certified birth record, driver's
3	license, or personal identification certificate to a homeless
4	individual.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subchapter A, Chapter 191, Health and Safety
7	Code, is amended by adding Section 191.00495 to read as follows:
8	Sec. 191.00495. BIRTH RECORD ISSUED TO HOMELESS INDIVIDUAL.
9	(a) In this section, "homeless individual":
10	(1) means an individual who:
11	(A) lacks a fixed, regular, and adequate
12	nighttime residence; or
13	(B) has a primary nighttime residence that is:
14	(i) a supervised publicly or privately
15	operated shelter designed to provide temporary living
16	accommodations, including welfare hotels, congregate shelters, and
17	transitional housing for persons with mental illness;
18	(ii) an institution that provides a
19	temporary residence for individuals intended to be
20	institutionalized; or
21	(iii) a public or private place not
22	designed for, or ordinarily used as, a regular sleeping
23	accommodation for human beings; and
24	(2) does not include an individual who is imprisoned

- 1 or otherwise detained in a correctional facility, unless the
- 2 individual satisfies the conditions described by Subdivision (1) at
- 3 the time of the individual's arrest.
- 4 (b) On request of a homeless individual, the state
- 5 registrar, a local registrar, or a county clerk shall issue,
- 6 without fee, a certified copy of the individual's birth record to
- 7 the individual.
- 8 (c) The department by rule shall:
- 9 (1) adopt a process to verify a person's status as a
- 10 homeless individual; and
- 11 (2) prescribe the documentation necessary for the
- 12 issuance of a certified copy of a birth record to a homeless
- 13 individual whose status is verified through the process adopted
- 14 under Subdivision (1).
- 15 (d) In adopting a verification process under Subsection
- 16 (c), the department shall allow a person requesting a birth record
- 17 to provide a letter certifying the person is a homeless individual
- 18 that is issued by the director of:
- 19 (1) an emergency shelter or transitional housing
- 20 program funded by the United States Department of Housing and Urban
- 21 <u>Development;</u>
- 22 (2) a shelter for homeless individuals;
- 23 (3) a transitional living program; or
- 24 (4) a law enforcement agency of a political
- 25 subdivision of this state that appoints or employs peace officers
- 26 as described by Article 2.12, Code of Criminal Procedure.
- (e) Notwithstanding any other law of this state, the

- 1 department may not require a homeless individual to provide a
- 2 physical address of the individual's residence to satisfy any
- 3 requirement of this section.
- 4 SECTION 2. Subchapter I, Chapter 521, Transportation Code,
- 5 is amended by adding Section 521.184 to read as follows:
- 6 Sec. 521.184. ISSUANCE OF LICENSE OR CERTIFICATE TO
- 7 HOMELESS INDIVIDUAL. (a) In this section, "homeless individual"
- 8 has the meaning assigned by Section 191.00495, Health and Safety
- 9 Code.
- 10 (b) The department by rule shall:
- 11 (1) adopt a process to verify a person's status as a
- 12 homeless individual;
- 13 (2) prescribe the documentation necessary for the
- 14 issuance of a driver's license or personal identification
- 15 certificate to a homeless individual; and
- 16 (3) exempt a homeless individual from the payment of
- 17 fees under this chapter for the issuance of a driver's license or
- 18 personal identification certificate, subject to Section 521.4265.
- 19 (c) In adopting a verification process under Subsection
- 20 (b), the department shall allow a person applying for a driver's
- 21 license or personal identification certificate to provide a letter
- 22 certifying the person is a homeless individual that is issued by the
- 23 director of:
- 24 (1) an emergency shelter or transitional housing
- 25 program funded by the United States Department of Housing and Urban
- 26 Development;
- 27 (2) a shelter for homeless individuals;

- 1 (3) a transitional living program; or
- 2 (4) a law enforcement agency of a political
- 3 subdivision of this state that appoints or employs peace officers
- 4 as described by Article 2.12, Code of Criminal Procedure.
- 5 (d) Notwithstanding any other law of this state and to the
- 6 extent permitted under federal law, the department may not require
- 7 <u>a homeless individual to provide a physical address of the</u>
- 8 individual's residence to satisfy any requirement of this chapter.
- 9 (e) Rules adopted under this section regarding the issuance
- 10 of a personal identification certificate to a homeless child or
- 11 youth, as defined by Section 521.1015, must be consistent with the
- 12 provisions of that section.
- SECTION 3. Sections 521.4265(b) and (c), Transportation
- 14 Code, are amended to read as follows:
- 15 (b) From the money in the identification fee exemption
- 16 account the department shall:
- 17 (1) request that the comptroller transfer to the Texas
- 18 Workforce Commission amounts sufficient to cover the cost of
- 19 implementing the program under Section 521.168, including amounts
- 20 sufficient for the payment by the Texas Workforce Commission of:
- 21 (A) fees to entities other than the department;
- 22 and
- 23 (B) the Texas Workforce Commission's
- 24 implementation costs; and
- 25 (2) for each exemption granted under Section 521.1015,
- 26 521.1016, [ex] 521.1811, or 521.184, deposit to the credit of the
- 27 Texas mobility fund an amount that is equal to the amount of the

- 1 waived fee that would otherwise be deposited to the mobility fund.
- 2 (c) The department may not:
- 3 (1) request a transfer under Subsection (b)(1) if the
- 4 balance of the account for the fiscal year is less than three times
- 5 the amount expended in the previous fiscal year for the waivers
- 6 provided by Sections 521.1015(e), [and] 521.1811, and 521.184; or
- 7 (2) grant an exemption under Section 521.1015,
- 8 521.1016, [or] 521.1811, or 521.184, if money is not available in
- 9 the identification fee exemption account to meet the requirements
- 10 of Subsection (b)(2).
- 11 SECTION 4. The changes in law made by this Act apply to an
- 12 application for a birth record, driver's license, or personal
- 13 identification certificate submitted on or after the effective date
- 14 of this Act. An application for a birth record, driver's license, or
- 15 personal identification certificate submitted before the effective
- 16 date of this Act is governed by the law in effect on the date the
- 17 application was submitted, and the former law is continued in
- 18 effect for that purpose.
- 19 SECTION 5. This Act takes effect September 1, 2023.
