(a) A mental health provider engages in unprofessional conduct if, in the course of 3 providing services to a child, the mental health provider attempts 4 5 to: 6 (1) change the child's sexual orientation, including 7 by attempting to change the child's behavior or gender identity or 8 expression; or 9 (2) eliminate or reduce the child's sexual or romantic attractions or feelings toward individuals of the same sex. 10 (b) Subsection (a) does not apply to counseling that: 11 12 (1) provides acceptance, support, and understanding of a child or facilitates a child's coping, social support, and 13 identity exploration and development, including sexual 14 15 orientation-neutral interventions to prevent or address unlawful conduct or unsafe sexual practices, if that counseling does not 16 17 seek to change sexual orientation or gender identity or expression; 18 or 19 (2) provides support to a child undergoing gender transition in accordance with established standards of care. 20 21 (c) A mental health provider who commits unprofessional conduct under Subsection (a) is subject to disciplinary action by 22 any state regulatory entity with the power to take disciplinary 23 24 action against that mental health provider. SECTION 5. This Act takes effect September 1, 2023. 25
