## A BILL TO BE ENTITLED 1 AN ACT 2 relating to the establishment of parentage and the duty to pay child 3 support. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Subchapter A, Chapter 154, Family Code, is amended by adding Section 154.0091 to read as follows: 6 Sec. 154.0091. RETROACTIVE CHILD SUPPORT ON ADJUDICATION OR 7 ACKNOWLEDGMENT OF PATERNITY. (a) Notwithstanding any other 8 9 provision of this chapter or other law, in any order rendered under Chapter 160, establishing a man's paternity of a child, or in any 10 suit to establish the child support obligation of a man whose 11 paternity has been established by the execution of a valid 12 acknowledgment of paternity in regard to the child under Subchapter 13 14 D, Chapter 160, the court shall order the man to pay retroactive child support for the child beginning on the earliest possible date 15 of the child's conception, as determined by a physician. 16 (b) In ordering retroactive child support under this 17 section, the court shall apply the child support guidelines 18 provided by this chapter and, on a proper showing, order the man to 19 pay an equitable portion of all of the prenatal and postnatal health 20 care expenses of the mother and the child. 21 (c) Notwithstanding Section 157.261 or any other law, 22 23 interest does not begin to accrue on a retroactive child support payment due under this section until the first anniversary of the 24

1 date the judge renders the order establishing the obligation.

2 SECTION 2. Section 160.304(c), Family Code, is amended to 3 read as follows:

4 (c) Subject to Subsection (a), an acknowledgment of
5 paternity or denial of paternity takes effect on [the date of the
6 birth of the child or] the filing of the document with the vital
7 statistics unit[, whichever occurs later].

8 SECTION 3. Section 160.502(b), Family Code, is amended to 9 read as follows:

10 (b) If a request for genetic testing of a child is made 11 before the birth of the child, the court or support enforcement 12 agency may [not] order in utero testing <u>only if:</u>

13

(1) the request is made by the pregnant mother; and

14 (2) the physician to perform the genetic testing 15 determines and certifies to the court that the testing would pose no 16 risk of harm to the pregnant mother or the child.

SECTION 4. Section 160.611, Family Code, is amended to read as follows:

19 Sec. 160.611. PROCEEDINGS BEFORE BIRTH. (a) A proceeding 20 to determine parentage commenced before the birth of the child may 21 not be concluded until after the birth of the child <u>unless the</u> 22 pregnant mother commences the proceeding.

(b) <u>Notwithstanding Subsection (a), in any [In a]</u> proceeding <u>to determine parentage commenced before the birth of the</u> <u>child</u> [described by Subsection (a)], the following actions may be taken before the birth of the child:

Sections 160.636(b) and (g), Family Code, are 5 amended to read as follows: (b) An order adjudicating parentage must identify the child 6 7 by name and date of birth, except that if the order is rendered 8 before the date of the child's birth: 9 (1) the order must identify the mother and father of the unborn child and the child's expected date of birth; and 10 (2) as soon as practicable after the date of the 11 12 child's birth, the order must be amended to identify the child by name and date of birth. 13 14 (g) On a finding of parentage, the court shall [may] order 15 retroactive child support as provided by Section 154.0091 [Chapter 154 and, on a proper showing, order a party to pay an equitable 16 17 portion of all of the prenatal and postnatal health care expenses of the mother and the child]. 18 SECTION 6. Section 160.636(h), Family Code, is repealed. 19 SECTION 7. The changes in law made by this Act with respect 20 to an order adjudicating paternity apply only to an order rendered 21 on or after the effective date of this Act. An order adjudicating 22 paternity rendered before the effective date of this Act is 23 24 governed by the law in effect on the date the order is rendered, and

26 SECTION 8. The changes in law made by this Act with respect 27 to an acknowledgment of paternity or denial of paternity apply only

the former law is continued in effect for that purpose.

to an acknowledgment of paternity or denial of paternity executed on or after the effective date of this Act. An acknowledgment of paternity or denial of paternity executed before the effective date of this Act is governed by the law in effect on the date the acknowledgment or denial is executed, and the former law is continued in effect for that purpose.

7 SECTION 9. The changes in law made by this Act to Section 8 160.611, Family Code, apply to a proceeding to determine parentage 9 that is pending on the effective date of this Act or filed on or 10 after that date.
