15	(2) suits involving the disconnection of utilities;
16	(3) repair and remedy suits;

18	(5) suits involving unlawful lockouts;

21	(7) any other category of suit involving a landlord or
22	tenant brought under Title 8, Property Code, and designated by the
23	council.
24	(b) The council may adopt rules as necessary to implement

1 this section. 2 SECTION 2. Subchapter C, Chapter 72, Government Code, is 3 amended by adding Section 72.0345 to read as follows: 4 Sec. 72.0345. LANDLORD AND TENANT DISPUTE INFORMATION. (a) 5 The office shall publish on the Internet website maintained by the office information on cases filed in justice courts related to 6 landlord and tenant disputes. The information must include for 7 8 each case: 9 (1) the justice court in which the case is filed, 10 including the precinct and county in which the court is located; 11 (2) whether any legal counsel or agent is representing 12 the defendant; 13 (3) whether any legal counsel or agent is representing 14 the plaintiff; and 15 (4) the disposition of the case. 16 (b) The office shall make the information required by 17 Subsection (a) available on the public information Internet website in a format that is searchable by date and jurisdiction. 18 19 SECTION 3. (a) As soon as practicable after the effective date of this Act: 20 (1) the Texas Judicial Council shall prescribe the 21 categories of landlord and tenant suits a justice court is required 22 to report under Section 71.0354, Government Code, as added by this 23 24 Act, and the procedures for reporting under that section; and 25 (2) the Office of Court Administration of the Texas 26 Judicial System shall publish in a searchable format on the public 27 information Internet website the landlord and tenant dispute

3 (b) Notwithstanding Section 71.0354, Government Code, as 4 added by this Act, a justice court is not required to report 5 landlord and tenant dispute information under that section until 6 after the Texas Judicial Council establishes the categories and 7 procedures for reporting under that section.
