1 Prostitution); or (3) if committed against a person of any age: 2 (A) Section 22.011 (Sexual Assault); or 3 (B) Section 22.021 (Aggravated Sexual Assault). 4 Notwithstanding Rules 404 and 405, Texas Rules of 5 (b) Evidence, evidence of other crimes, wrongs, or acts committed by 6 the defendant against the [child who is the] victim of the alleged 7 8 offense shall be admitted for its bearing on relevant matters, including: 9 10 (1) the state of mind of the defendant and the victim [child]; and 11 12 (2) the previous and subsequent relationship between the defendant and the victim [child]. 13 14 SECTION 2. Section 22.021 [Sections 22.021(a)(1)(B) and 1 (E) (2)] (Aggravated Sexual Assault [of a Child]); 2 3 (F) Section 33.021 (Online Solicitation of а 4 Minor); 5 (G) Section 43.25 (Sexual Performance by а 6 Child); or Section 43.26 (Possession or Promotion of 7 (H) 8 Child Pornography), Penal Code; or (2) an attempt or conspiracy to commit an offense 9 described by Subdivision (1). 10 11 SECTION 3. The change in law made by this Act applies to the admissibility of evidence in a criminal proceeding that commences 12 on or after the effective date of this Act. The admissibility of 13 evidence in a criminal proceeding that commences before the 14 15 effective date of this Act is governed by the law in effect on the date the proceeding commenced, and the former law is continued in 16 17 effect for that purpose.
