A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the regulation of sports wagering; requiring
- 3 occupational permits; authorizing fees; imposing a tax;
- 4 decriminalizing wagering on certain sports events; creating
- 5 criminal offenses; providing administrative penalties.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. The Legislature finds the following:
- 8 (1) consistent with a 2018 United States Supreme Court
- 9 decision authorizing states to exercise their lawful prerogative to
- 10 license and regulate sports wagering activity, it is in the
- 11 interest of this state to authorize a strict regulatory model for
- 12 sports wagering;
- 13 (2) a legal, regulated sports wagering market will
- 14 help to deter unlawful sports wagering and provide for more
- 15 regulatory and law enforcement oversight over sports wagering,
- 16 while generating state revenue;
- 17 (3) any sports wagering enforcement and regulatory
- 18 structure must begin from the bedrock premise that participation in
- 19 a lawful and licensed sports wagering industry is a privilege and
- 20 not a right and that strict regulatory oversight is intended to
- 21 safeguard the integrity of wagering on sporting events and to
- 22 ensure accountability and the public trust;
- 23 (4) the most expeditious way to legalize sports
- 24 wagering in this state and to strictly regulate this activity is to

(26) "Sports wagering platform" means an Internet 18 website, mobile application, or other interactive platform 19 accessible through or by means of the Internet, a mobile device, or 20 any other telecommunications service that sports wagering players 21 22 may use to place sports wagers and participate in sports wagering 23 authorized under this chapter. 24 (27) "Tier one sports wager" means any sports wager 25 other than a tier two sports wager.

- Sec. 2005.003. COMPLIANCE WITH FEDERAL AND STATE LAW. (a)

 All sports wagering authorized under this chapter must be

 initiated, received, and otherwise placed within the boundaries of

 this state unless otherwise authorized by commission rule adopted

 in accordance with applicable federal and state laws.
- 15 (b) The intermediate routing of electronic data relating to
 16 Internet sports wagering authorized under this chapter, including
 17 routing across state lines, does not determine the location in
 18 which wagers are initiated, received, or otherwise placed,
 19 consistent with the Unlawful Internet Gambling Enforcement Act of
 20 2006 (31 U.S.C. Section 5361, et seq.).
- 21 <u>Sec. 2005.004. INAPPLICABILITY OF CHAPTER TO CERTAIN</u>

- 8 SUBCHAPTER B. COMMISSION POWERS AND DUTIES
- 9 Sec. 2005.051. SPORTS WAGERING PROGRAM. (a) The commission

- Sec. 2005.057. RISK MANAGEMENT. (a) The commission shall
- 26 adopt rules allowing interactive sports wagering operators and
- 27 their service providers to use systems that offset loss or manage

- 2 including through liquidity pools, exchanges, or similar

- 21 commission, as necessary to protect the integrity of a competition
- 22 or its participants or as described in Section 2005.060, may
- 23 suspend wagering on any competition, category or type of
- 24 competition, or other aspect of a competition.
- Sec. 2005.060. LIMITATIONS ON CERTAIN SPORTS WAGERING FOR
- 26 GOOD CAUSE. (a) If a sports governing body believes that the type,
- 27 form, or category of sports wagering on that sports governing

- 1 body's sporting events has the potential to undermine the integrity
- 2 or perceived integrity of the sports governing body or its sporting

- (e) If the commission determines the requestor who
- 23 submitted a request under Subsection (a) is likely to prevail in
- 24 successfully demonstrating good cause for its request, the
- 25 commission may provisionally grant the request until the commission
- 26 issues a final determination on whether the requestor has
- 27 demonstrated good cause. Absent a provisional grant by the

- 2 offer sports wagering on sporting events that are the subject of a

- 5 Sec. 2005.061. MONITORING PROGRAM. The commission by rule
- 6 shall adopt and administer a monitoring program sufficient to

- 10 states.
- 11 SUBCHAPTER C. SPORTS WAGERING PERMITS
- 12 Sec. 2005.101. INTERACTIVE SPORTS WAGERING PERMIT
- 13 APPLICATION; FEE. (a) The commission shall issue not more than one
- 14 interactive sports wagering permit for each authorized sports
- 15 entity under this chapter. Each sports entity may designate only
- 16 one sports entity designee as an authorized sports entity.
- 17 (b) The commission shall issue an interactive sports
- 18 wagering permit to an authorized sports entity that:

- 15 (5) the applicant's written information security
- 16 program, including information security governance and the
- 17 designation of a chief security officer or equivalent;
- 18 <u>(6) the single sports wagering brand under which an</u>
- 19 interactive sports wagering operator plans to hold out its sports
- 20 wagering platform to the public;
- 21 (7) any personal information the commission by rule
- 22 may determine is required for the applicant's key persons; and
- 23 (8) any other information the commission considers
- 24 necessary.
- Sec. 2005.102. SERVICE PROVIDER PERMIT APPLICATION; FEE.
- 26 (a) An applicant for a service provider permit shall:
- 27 (1) submit an application to the commission, on a form

- 1 prescribed by the commission, containing the information required
- 2 by this section; and
- 3 (2) pay to the commission an application fee in an
- 4 amount equal to \$25,000.
- 5 (b) An application submitted under this section must
- 6 include:
- 7 (1) the applicant's background in sports wagering or a

- 9 (2) the applicant's experience in connection with
- 10 sports wagering or other wagering activities in other
- 11 jurisdictions, including the applicant's history and reputation of

- Sec. 2005.103. BACKGROUND CHECK. The commission shall
- 24 conduct a background check on each service provider applicant,
- 25 including any key persons of the applicant, as required by
- 26 commission rule. A background check conducted under this section
- 27 must include a credit history check, a tax record check, and a

1 criminal history record information check. Sec. 2005.104. GRANT OR DENIAL. (a) The commission shall 2 3 grant or deny a completed application under this subchapter not later than the 90th day after the date the commission receives the 4 application. The commission's decision is final and not 5 appealable, except as otherwise required under state law. 6 7 (b) The commission may accept a license, permit, or any 8 other authorization to operate sports wagering issued by another jurisdiction that the commission specifically determines has 9 similar permitting requirements as evidence that the applicant 10 meets the interactive sports wagering operator requirements. The 11 12 commission may accept another jurisdiction's or an approved third party's testing of the interactive sports wagering platform as 13 evidence that the platform meets any requirements mandated by 14 commission rule. 15 (c) The commission shall grant a permit to an applicant for 16 17 a service provider permit unless: 18 (1) the commission reasonably believes: 19 (A) the applicant will be unable to satisfy the duties of a service provider under this chapter; 20 21 (B) the applicant or a key person of the 22 applicant is not of good character, honesty, or integrity; or (C) the applicant's or a key person of 23 24 applicant's prior activities, criminal record, reputation, or 25 associations are likely to: 26 (i) pose a threat to the public interest; 27 (ii) impede the regulation of sports

2 (iii) promote unfair or illegal activities 3 in the conduct of sports wagering; 4 (2) the applicant or a key person of the applicant 5 knowingly fails to comply with the provisions of this chapter or a 6 commission rule under this chapter; 7

- (3) the applicant or a key person of the applicant has 8 been previously convicted of a felony, a crime of moral turpitude, or any criminal offense involving dishonesty or breach of trust in 9 10 the 10 years preceding the date the application is submitted;
- (4) the applicant's or a key person of the applicant's 11 12 license, registration, or permit to conduct sports wagering, other forms of gambling activity, or a covered service issued by another 13 14 state has been revoked; or
- 15 (5) the applicant defaults in payment of any obligation or debt due to this state. 16
- 17 Sec. 2005.105. CONFIDENTIAL INFORMATION. Notwithstanding any other law, the information an applicant submits under this 18 19 subchapter is confidential and exempt from public disclosure.
