11	under Section 25.02, Penal Code. This subsection may not be
12	construed to require:
13	(1) the pregnant patient to file a police or
14	investigative report;
15	(2) the pregnant patient to provide forensic evidence;

3	SECTION 4. Section 171.206(b), Health and Safety Code, is
4	amended to read as follows:

8	abortion is performed or induced or attempted to be performed or

a vote of two-thirds of all the members elected to each house, as
provided by Section 39, Article III, Texas Constitution. If this
Act does not receive the vote necessary for immediate effect, this
Act takes effect September 1, 2023.
