| 13 | blanket, or franchise insurance policy or insurance agreement, a     |
| 14 | group hospital service contract, or an individual or group evidence  |
| 15 | of coverage or similar coverage document that is offered by:         |
| 16 | (1) an insurance company;  |
| 17 | (2) a group hospital service corporation operating                   |
| 18 | under Chapter 842;   |
| 19 | (3) a health maintenance organization operating under                |

| 6  | Sec. 1380.002. COVERAGE PROHIBITED. (a) A health benefit            |
| 7  | plan issuer may not cover a human organ transplant if:              |
| 8  | (1) the transplant operation is performed in China or               |
| 9  | another country known to have participated in organ harvesting, as  |
| 10 | designated by the commissioner of state health services; or         |
| 11 | (2) the human organ to be transplanted was procured by              |
| 12 | a sale or donation originating in China or another country known to |
| 13 | have participated in organ harvesting, as designated by the         |
| 14 | commissioner of state health services.                              |
| 15 | (b) The commissioner of state health services may designate         |
| 16 | additional countries who are known to have participated in organ    |
| 17 | harvesting and shall provide written notice to the commissioner,    |
| 18 | Teacher Retirement System of Texas, Employees Retirement System of  |
| 19 | Texas, and executive commissioner of the Health and Human Services  |
| 20 | Commission when the commissioner of state health services           |
| 21 | designates an additional country.                                   |

SECTION 2. If before implementing any provision of this Act a state agency determines that a waiver or authorization from a federal agency is necessary for implementation of that provision, the agency affected by the provision shall request the waiver or authorization and may delay implementing that provision until the waiver or authorization is granted.

1 SECTION 3. Chapter 1380, Insurance Code, as added by this 2 Act, applies only to a health benefit plan delivered, issued for 3 delivery, or renewed on or after January 1, 2024.

4 SECTION 4. This Act takes effect September 1, 2023.
