7	Sec. 1001.201. DEFINITIONS. In this subchapter:
8	(1) "Child-care facility" has the meaning assigned by
9	Section 42.002, Human Resources Code.
10	(2) "Educator" means a person who is required to hold a
11	certificate issued under Subchapter B, Chapter 21, Education Code.
12	(3) "First responder" has the meaning assigned by
13	Section 421.095, Government Code.
14	(4) "Institution of higher education" has the meaning
15	assigned by Section 61.003, Education Code.

- 2 <u>(9)</u> [(4)] "School district employee" means a person
- 3 employed by a school district who regularly interacts with students
- 4 through the course of the person's duties, including an educator, a
- 5 secretary, a school bus driver, or a cafeteria worker.
- 6 [(5) "School resource officer" has the meaning
- 7 assigned by Section 1701.601, Occupations Code.
- 8 [(6) "University employee" means a person employed by
- 9 a public or private institution of higher education who regularly
- 10 interacts with students enrolled at the university through the

- 12 SECTION 2. Section 1001.202, Health and Safety Code, is
- 13 amended to read as follows:
- 14 Sec. 1001.202. GRANTS FOR TRAINING OF MENTAL HEALTH FIRST
- 15 AID TRAINERS. (a) To the extent money is [funds are] appropriated
- 16 to the commission [department] for that purpose, the commission
- 17 [department] shall make grants to local mental health authorities
- 18 or local behavioral health authorities to contract with persons
- 19 approved by the commission [department] to train employees or
- 20 contractors of the authorities as mental health first aid trainers.
- 21 (b) The <u>commission</u> [department] shall make each grant to a
- 22 local mental health authority or local behavioral health authority
- 23 under this section in the [an] amount the commission determines
- 24 necessary to cover the costs of training [equal to \$1,000 times the
- 25 number of employees or contractors of the authority whose training
- 26 as mental health first aid trainers will be paid by the grant.
- 27 (d) The executive commissioner shall adopt rules to

- 2 commission [department] to train employees or contractors of a

- 4 as mental health first aid trainers. The rules must ensure that a
- 5 person who is approved by the commission [department] is qualified
- 6 to provide training in:
- 7 (1) the potential risk factors and warning signs for
- 8 various mental illnesses, including depression, anxiety, trauma,
- 9 psychosis, eating disorders, substance use [abuse] disorders, and
- 10 self-injury;
- 11 (2) the prevalence of various mental illnesses in the
- 12 United States and the need to reduce the stigma associated with
- 13 mental illness;
- 14 (3) an action plan for use by the employees or
- 15 contractors that involves the use of skills, resources, and
- 16 knowledge to assess a situation and develop and implement an
- 17 appropriate intervention to help an individual experiencing a
- 18 mental health crisis obtain appropriate professional care; and
- 19 (4) the evidence-based professional, peer, social,
- 20 and self-help resources available to help individuals with mental
- 21 illness.
- (e) Two or more local mental health authorities or local
- 23 <u>behavioral health authorities</u> may collaborate and share resources
- 24 to provide training for employees or contractors of the authorities
- 25 under this section.

- Sec. 1001.203. GRANTS FOR TRAINING CERTAIN INDIVIDUALS 1 [UNIVERSITY EMPLOYEES, SCHOOL DISTRICT EMPLOYEES, AND SCHOOL 2 RESOURCE OFFICERS] IN MENTAL HEALTH FIRST AID. - 2 local mental health authority or local behavioral health authority
- 3 the amount the commission determines necessary to cover the costs
- 4 of training each individual described by Subsection (a) [for each
- 5 university employee, school district employee, or school resource
- 6 officer] who successfully completes a mental health first aid
- 7 training program provided by the authority under this section.
- 8 (d) A mental health first aid training program provided by a
- 9 local mental health authority or local behavioral health authority
- 10 under this section must:
- 11 (1) be conducted by a person trained as a mental health

- 13 (2) provide participants with the skills necessary to

- 2 and the training program completed; and
- 3 (5) a detailed accounting of expenditures of money
- 4 appropriated for the purpose of implementing this subchapter.
- 5 (c) The commission [department] shall develop and provide
- 6 to local mental health authorities <u>and local behavioral health</u>
- 7 <u>authorities</u> a form to be used for the reporting of information
- 8 required under Subsection (a), including the reporting of each
- 9 category of personnel described by that subsection.
- 10 SECTION 6. Section 1001.206, Health and Safety Code, is
- 11 amended to read as follows:
- 12 Sec. 1001.206. LIABILITY. A person who has completed a
- 13 mental health first aid training program offered by a local mental
- 14 health authority or local behavioral health authority under this
- 15 subchapter and who in good faith attempts to assist an individual
- 16 experiencing a mental health crisis is not liable in civil damages
- 17 for an act performed in attempting to assist the individual unless
- 18 the act is wilfully or wantonly negligent.
- 19 SECTION 7. The following sections of the Health and Safety
- 20 Code are repealed:
- 21 (1) Section 1001.2015; and
- 22 (2) Section 1001.2031.
- 23 SECTION 8. This Act takes effect September 1, 2023.
